Vets' Spirits Lifted on Hudson Valley Honor Flight #11

On Saturday, April 2nd, Donald Vandenberg who resides in Liberty and served in the Navy during the Iwo Jima and Okinawa Campaigns was joined by 81 well-deserving veterans for the Hudson Valley Honors Flight Mission #11.

Glenn Vandenberg was the Guardian for his father on the flight.

Captain Frank and Elizabeth Morley who have a summer home in Claryville were also attended the event. Captain Morley works in the Pentagon

Elizabeth Morley commented, "Frank wore his uniform and looked very handsome. Most of the old Navy vets stopped him to exclaim "You look too young to be a captain!" or "Last time I saw a captain he was yelling at me!" or "I've never shook the hand of a braid before"! It was great to see their eyes light up when Frank very graciously greeted them and asked about their sea duty and thanked them for their service. He was thrilled to be part of their day."

Many of the WWII veterans who now are well into their 90s and would have otherwise had difficulty due to disabilities or finances were able to visit the war monuments for the first time. A grand reception was also provided for the vets who certainly deserve the recognition they had never received.

The Hudson Valley Honor Flights are a growing success. With each flight the organization has broadened their efforts from hosting one flight a year in the beginning and now to four flights a year and planning to schedule a fifth flight.

Hudson Valley Honor Flight will hold its 12th journey out of Westchester Airport on May 14 and expects to honor its 1,000th veteran served on Sept. 10 on its planned 13th flight, which will be from Stewart.

Today's History

April 11, 1956 - A daughter was born on Monday to Mr. and Mrs. Harold Brown of lower South Hill, at Veterans Memorial Hospital in Ellenville. The baby was named Denise Marie and she weighed 9 lbs. 10 oz. The maternal grandparents are Mr. and Mrs. Edwin Stratton and Mrs. Elmer Sheeley is the baby's great-grandmother.

An April shower turned to snow over the weekend and deposited from ten to twenty-four inches of the white stuff over the Tri Valley area. On Red Hill, Greenville, Blue Hill and Aden huge drifts complicated the task of opening the roads and isolated people temporarily. At Grahamsville where the rainfall turned to snow early Sunday morning, ten inches was measured by N.Y.C.B.W.S. gage keeper, Jack Donaldson.

April 13, 1966 - Helicopter pilot John Nielsen of Neversink is one of five crew members commended for outstanding display of professional skill in a dramatic evacuation of wounded from a downed aircraft in an area subject to hostile ground fire near Cho Gao, South Vietnam. Nielsen, the son of Mr. and Mrs. Charles Nielsen of Neversink, is married to the former Darlene Garber.

David Dole has been accepted as a full time student at SCCC. He will study commercial art. He has studied art for four years of high school at Tri Valley Central School and Liberty Central School.

April 21, 1976 - Congressman Matthew F. McHugh announced that Elaine C. Stratton, 18, of Grahamsville, has been accepted at the U.S. Military Academy at West Point. Elaine is the first woman from the 27th District to be admitted to a service academy under a bill signed into law last fall which opened the academies to women for the first time. She is the daughter of Mr. and Mrs. Vernon Stratton of Grahamsville.

John Kemble Sr. of Kingston passed away on April 14, 1976 at home after a long illness. Born in Kingston on April 4, 1902 to the late Henrietta Hubbard Kemble of Rhinebeck and Dr. U.T. Kemble of Hurley, he was a former resident of Eureka and Grahamsville. He is survived by his wife, Esther McCain Kemble; one daughter, Mrs. Donald (Sally) Krom; two sons, John Jr. and William, both of Hurley; and seven grandchildren.

April 24, 1986 - Kimberly Curry, daughter of Mr. and Mrs. Robert Curry, has been named Valedictorian of the class of 1986. A New York State Regents Scholar, Kim has compiled an academic average of 97.2% in her four years of high school. Kim will major in computer and mathematical sciences at Chestnut Hill College, from which she received a full-tuition Presidential scholarship. Mary Weise, daughter of Mr. and Mrs. Joe Weise has been named Salutatorian. She has compiled an academic average of 94.9% during her four years of high school. A new website by the Watershed Agricultural Council helps landowners and outdoor enthusiasts discover land-based activities that fit them, their woods, and their lifestyles. It's called *MyWoodlot*. The website lists 10 broad interests like Nature, Recreation, and Timber Production. Each interest is then divided into goals landowners can work toward, with each goal made up of

several activities, linking to factsheets, photo slideshows, videos, professional contact lists, and even a few smartphone apps. Though designed for private landowners, the site offers many activities that anyone can perform when spending time outdoors. The site's Recreation interest, for example, includes topics like wildlife watching, tapping a maple tree, cross-country skiing, and how to avoid ticks and tick-based illnesses like Lyme Disease.

MyWoodlot is available free for anyone to use thanks to funding from the US Forest Service and the New York City DEP.

The Public Health Works! Honor Roll recognizes the local public health workforce as an essential component of Commissioner of Health Howard A. Zucker's public health agenda to make New York one of the healthiest states in the nation. At the heart of all successful public health initiatives are the workers who promote and protect the public's health and safety.

Maternal Child Health (MCH) nurses at Sullivan County Public Health Services (SCPHS) perform skilled nursing visits to pregnant, postpartum and pediatric patients throughout Sullivan County. Anne Mikulski RN, Supervising Community Health Nurse (SCHN) supervises a team of two full time MCH nurses, Janna Worden RN and Martha Wilcox, Community Health Nurse (CHN). Janna and Martha see complex MCH cases, participate in designing orientation training and in-services, and perform developmental screenings for the Early Care program and visits for the Lead Poisoning Prevention Program. MCH nurses also work with New York State's Newborn Screening Program. Sullivan County has a high rate of premature and caesarian deliveries. In 2015, the MCH program performed over 1000 skilled nursing visits to MCH patients. The MCH nursing team makes a valuable contribution to improving Public Health in this rural county by providing high risk women and children with critically important home based nursing services.

New York State relies on its local health departments to promote, protect and improve the health of residents. The core public health services administered by New York's 57 local health departments and the New York City Department of Health and Mental Hygiene include Communicable Disease Control, Chronic Disease Prevention, Community Health Assessment, Environmental Health, and Emergency Preparedness and Response.

Without these local health departments and their dedicated employees, these essential services would not be provided. The Honor Roll recognizes the outstanding workers that keep New Yorkers healthy.

Lasting Impressions of the Skunk

Saturday morning I woke up to the dog barking at something in the back yard. This time of the year, you never know what might be lurking through the woods looking for something to eat. My first guess was a bear, but the magical light of the early dawn etched a familiar silhouette of a visitor we haven't seen in a while. A beautiful big black and white skunk who was either looking for a mate or most likely, some fresh food.

The "skunk family" ("Mephitidae") belongs to the order Carnivora. The skunk species vary in size from about 15.6 to 37 in and in weight from about 1.1 lb to 18 lb. They have moderately elongated bodies with relatively short, well-muscled legs, and long front claws for digging.



Although the most common fur color is black and white, some skunks are brown or grey, and a few are cream-colored.

Skunks are omnivorous, eating both plant and animal material and changing their diets as the seasons change. They eat insects and larvae, earthworms, grubs, small rodents, lizards, salamanders, frogs, snakes, birds, moles, and eggs. They also commonly eat berries, roots, leaves, grasses, fungi, and nuts. This particular fellow looked content nibbling on the leftovers from Easter that I had tossed out on the compost heap.

Once in awhile a skunk will act like a scavenger, and eat bird and rodent carcasses left by cats or other animals.

In the Catskills skunks retreat to winter dens, however they are not true winter hibernators. They do den up for extended periods of time, and generally remain inactive and eat very sparingly as they go through a dormant stage. Over winter, as many as 12 females huddle together in one den that they use year after year. The males often den alone and are likely to be active above ground, especially during the mating season in February. Skunks are a polygamous species, meaning males usually mate with more than one female.

Before giving birth, around May, the female will excavate a den which is often in a woodchuck burrow, to house her litter of four to seven kits. The young kits are blind, deaf, and covered in a soft layer of fur. About three weeks after birth, their eyes open. The kits are weaned around two months after birth, but generally stay with their mother until they are ready to mate, when they are a year old.

Skunk live in a variety of habitats but prefer open areas. Residential areas that have both lawns and large shade trees often provide the optimal habitat for skunks.

Like the more glamorous members of the weasel family (mink, otter, fisher and marten), the skunk also has glossy and durable fur that can be dyed uniformly black for exquisite garment trimming. The striped skunk has been protected under the Environmental Conservation Law since the late 1800s when the pelts of the striped skunk were more valuable than they are in the current fur market.

A skunk, sometimes called a polecat is best known for its ability to secrete a liquid with a strong, noxious substance, known as n-butyl mercaptan, that protects them so well against potential enemies, including bear. The spray can cause irritation and even temporary blindness, and is sufficiently powerful to be detected by a human nose up to a mile down wind.

Odd as it may seem, skunk musk is very valuable and important to the perfume industry. Once the acrid odor is removed, it is used as a perfume base due to its clinging quality. At the core of expensive designer perfumes, including *Lasting Impressions*, it is the little furry animal, a skunk, whose scent may have helped to add to the price.

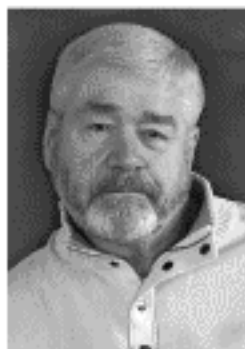
Have a New Puppy or Kitten? Unmark Your Pet's Spots

When housebreaking a puppy or kitten, it'll often wet previously soiled spots. After cleaning up the mess, it's essential to remove the scent from your floor, carpeting, or sofa. And nothing does that better than vinegar:

One of the great things about reading is when you figure out that it's a voyage of personal discovery . . . and the more you read, the longer your journey into the unknown, which in turn takes you to places you couldn't imagine before opening that book you've just read . . . and ever farther into the ocean of learning. That's as big a mouthful of metaphor as I've ever written. But the truth is, I was inspired to it by this week's MBR No. 236, the one with the short, humble title.

The Cellar: A Novel (Penguin/Random House, \$24.00, 246 pages, ISBN 978-0-09-959464-2) by Edgar-awarded, best-selling British author Minette Walters is a compelling psychological thriller that takes the reader deep into the heart, mind and soul of another. It's a ride that'll stick with you long after you've finished reading.

A young black girl named Muna is stolen from an African orphanage by the Songoli family and taken to England, where for the next ten years Muna is held as a slave. She's forced to do all of the cleaning, cooking, washing and ironing for 'Princess' and 'Master,' as Muna is forced to address Mr. and Mrs. Songoli, as well as their two sons. Muna lives in the basement, where there's no light, no heat, no windows and no escape. She can't read, or write, or talk to anyone. She's never been outside the house where she's imprisoned, never seen the sky or gone to school. She's regularly beaten with a rod by Princess, forced into sex acts by Master and appears destined for similar treatment by one or both teenage sons in the very near future, because as the older one tells her, "You're worthless. I can do anything I want to you." But one day, the Songoli's younger son Abiola, fails to come home from school . . . and everything changes. Little Muna isn't quite as helpless as everyone thought she was. She has a scheme of her own: terrifying plans that will affect them all. It's a nightmare . . . and it's only just beginning.

Minette Walters has been called a "A rare talent with an unnerving imagination . . ." who "takes the suspense novel into new territory" . . . and "patrols the darkest areas of the human heart." Nothing in *The Cellar* contradicts those notions from some of the world's leading news organizations-with whom I heartily agree. If you enjoy the work of John Connolly, Peter Straub, Stephen King or Robert E. Howard, you're in for a treat when you discover Minette Walters, who, like Ann Rice, will take you for a ride on the dark side . . . and deep into the psyche of some of the most different human minds anyone ever imagined.

Sullivan County Accepting Agricultural District Applications

Sullivan County is accepting applications from property owners seeking to be included in New York State Agricultural Districts 1 and 4, for a 30-day window beginning April 1st and ending April 30th. New York State Agricultural Districts are geographic areas that consist predominantly of viable agricultural land. Agricultural operations within the districts are afforded benefits and protections to promote the continuation of farming and the preservation of agricultural land. These benefits include protection of farming from unreasonable restrictive local laws, limitations on assessments for newly formed benefit districts, and

governments notification of projects that could adversely affect farmland.

There are two New York State Agricultural Districts in Sullivan County. Agricultural District 1 encompasses towns in northern and western Sullivan County, and Agricultural District 4 covers the County's eastern and southern towns.

For parcels to be included in an Ag District, they must be predominantly viable agricultural land. New York State Department of Agriculture and Markets Law, defines "viable agricultural land" as land highly suitable for agricultural production and which will continue to be economically feasible for such use if real property taxes, farm use restrictions and speculative activities are limited to levels approximating those in commercial agricultural areas not influenced by the proximity of non-agricultural development.

During this thirty day window, property owners may request the addition of their land into an Agricultural District. Applications are available by calling Melinda Meddaugh, at Cornell Cooperative Extension Sullivan County at 845-292-6180, or by emailing her at mm2592@cornell.edu. Applications will be reviewed by the Sullivan County Agricultural and Farmland Protection Board, who will then make recommendations to the County Legislature regarding property to be added to the districts this year. The County Legislature will hold a public hearing and then vote on the approval of each recommended addition. Subsequent to County approval, an updated district map with a report showing the new parcels for inclusion in the districts will be submitted to the State Department of Agriculture and Markets for State approval. Upon approval by Agriculture and Markets, each property owner will be notified by mail and the real property tax records for each parcel will be updated. Applicants will receive notification by the fall.

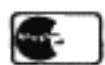

The Tax Man Cometh

The Ides of March brought unusually warm weather and a glimpse of spring. What are Ides, you say? The Romans did not number days of a month sequentially from the first through the last day. Instead, they counted backwards from three fixed points of the month: the Nones (5th or 7th), the Ides (13th or 15th), and the Kalends (1st of the next month). The Ides occurred near the midpoint, on the 13th for most months, but on the 15th for March, May, July, and October. The Ides were supposed to be determined by the full moon, reflecting the lunar origin of the Roman calendar. The Ides of March were usually associated with dread and doom since it was the day that Julius Caesar was assassinated in 44 B.C. marking the turning point in history when Rome moved from being The Roman Republic to being known as The Roman Empire.

The Ides of April are now upon us. Snow and taxes are the forecast for the coming week. April's Ides are accompanied by anxiety and anticipation. It is an ominous deadline looming between scarves and mittens and Mother's Day flowers.

I personally think the tax laws should be revised. First of all, my furry dependents do not get a deduction even though they cost me more in medical bills this year than did my husband. Shopping at Sam's, I realized that the case of dog food, the case of Milk Bones, the fifty-pound bag of bird seed, and the case of cat food added up to a whopping \$72.00 while my rotisserie chicken was only \$4.99.

The exemption amount for an infant (first year) should be doubled, and the exemption for a college student should be quadrupled that of any other year. Two cars, one house, a year's supply of Ramen Noodles and one smart phone should be considered necessities for survival. The baseline for comfortable living should be raised to the level of our local senator. We could do this by making the first \$275,000. tax exempt. We all can pay income taxes on excess income above that.

With apologies to Woody Guthrie for expropriating his song title . . . Are you a thinking person? Do you give a damn about your family? How about your kids? Grandkids? Even your great-grandkids and all those who'll be born after? Everyone in America should read this piece and make others aware of it too. When finished, you're going to say, "I don't believe it." But then, you'll get a calculator and prove it to your own satisfaction . . . after which, you're going to be angry. Read on. Learn why I'm sticking my neck out with these statements. I didn't believe it either. It has to do with numbers.

Suppose that we had to borrow money-and agreed to pay it back at the rate of one dollar every second. At that amount, an average home mortgage of, say \$150,000, would be fully repaid in just 39 hours-or a little more than one and a-half days. Thirty-year mortgage? *Fuhgetaboutit!*

At the dollar a second rate, a one million dollar loan would be paid back in eleven days and four hours. Think of the interest we'd save! And hold that thought . . . because here's where we have to step up our game.

For years, our elected representatives who spend our tax money have tossed around phrases using numbers in the billions of dollars range. Thirty years ago, Illinois Senator Everitt Dirksen was quoted as saying "A billion here, a billion there, pretty soon you're talking about real money," in a humorous aside. Now, the 'B' in billions has been replaced with an innocent sounding 'T', as in trillions - an innocuous but incomprehensible number we'd like to put into more understandable terms.

At one dollar per second, it takes 32 years to repay a one billion dollar loan, but it takes 32 thousand years to repay a one trillion dollar loan.

It takes 32 thousand years to repay one trillion dollars at the rate of a buck a second.

That's not a mistake. I didn't believe it either. Check it out. Prove it to your own satisfaction. Then realize that those same politicians whom we elected to do our nation's business have spent 20 trillion dollars that they don't have, and multiply the above 32 thousand by 20. It's 640 thousand years! There is a day of reckoning coming. It's known as the tipping-point. That's the spot where we reach insolvency - the place where our ability to repay is less than the amount owed. It's called bankruptcy. It's real. We're headed for it at some point in the not-too-distant future when our kids' kids and their kids will get stuck with our bills.

Oh, and one last thought. We didn't bother to mention the interest on the Dough-Re-Mi that's been borrowed. It adds up-even at the unprecedented current rate of .0025 percent-at more than one dollar per second . . .

A Schneiderman: New Yorkers Should Remain Vigilant During Tax Season, Follow Tips To Stay Safe, And Report Suspected Scams

NEW YORK - With this year's tax deadline looming and April marking National Financial Literacy Month, Attorney General Eric T. Schneiderman today offered New Yorkers tips to avoid falling victim to reported tax season scams. The Attorney General also asked taxpayers to notify his office of any suspected fraudulent schemes designed to steal personal and financial information from consumers.


"Some of the most common scams reported to my office involve fraudsters targeting consumers during tax season and I hope New Yorkers remain vigilant leading up to tax day," said Attorney General Schneiderman. "By keeping in mind a few basic tips and reporting suspected fraud, consumers can stay safe and ensure that they get to keep the full tax refund to which they're entitled."

Each year, the Office of the Attorney General receives complaints from consumers about various tax preparation schemes. This year, the Attorney General's Office has received numerous complaints about scammers who are impersonating IRS officials and attempting to collect bogus tax debts. The scammers often threaten lawsuits or arrest if consumers fail to turn over money or provide sensitive personal information. Often the scammers claim consumers owe past tax debts and insist that consumers pay using a pre-paid credit card. Pre-paid credit cards are generally difficult to trace and that is why many scammers insist that would-be scam victims pay using these products. A sample IRS scam call can be found here.

In an effort to help New Yorkers avoid tax-themed scams, the Attorney General's Office offers the following tips:

- o The IRS and legitimate government agencies never demand payment by phone;
 - o If you owe money, you will receive a legitimate notice in writing that identifies the agency and the reason you owe money;
 - o Do not give out personal information, including your Social Security number or bank account information, to telephone callers;
 - o Legitimate government organizations will never threaten arrest or deportation for failure to pay a debt;
 - o Legitimate government agencies will never insist that consumers pay a debt only via a pre-paid credit card.
- The following suggestions will help consumers file their tax returns safely and keep more of their return:
- o If you use a tax-preparation service, use only established and recognizable companies;
 - o Check the tax preparer's qualifications and history through the Better Business Bureau (bbb.org);
 - o Ask for a written estimate of all fees; avoid those who base their fees on a percentage of your refund;
 - o Make sure the tax preparer is accessible, even after the April due date;
 - o Never sign a blank return;
 - o Review entire return before signing;
 - o Make sure the preparer signs the tax form and includes a Preparer Tax Identification Number (PTIN);
 - o Consult New York's "Consumer Bill of Rights Regarding Tax Preparers."

Consumers should also beware of refund anticipation loans (RALs) and refund anticipation checks (RACs). RALs are often marketed as "instant" or "24-hour" refunds but are actually high-cost loans that come with fees and interest that reduce the amount of any refund. (Contd. Pg. 12)

Assembly Continues Commitment to Expanding Ethics Reform and Sunshine Legislation

(Albany, NY) - Assemblymember Kevin A. Cahill (D-Ulster, Dutchess) commented on the Assembly's efforts to increase the transparency of our state government and limit the power of special interests by passing comprehensive legislative initiatives that address ethics and campaign finance reform. The Assembly also passed a measure that would require state agencies that maintain websites to permit the online submission of requests for records that are subject to FOIL (A.5768, People-Stokes).

"It is unfortunate, but New Yorkers have lost faith in their public institutions. We can restore that trust by our own good behavior as lawmakers and by taking measures to increase accountability," Assemblymember Cahill said. "I am confident the passage of this significant legislation will be a valuable step toward rebuilding the faith our constituents must have in their representatives in order to effectively govern."

The Assembly approved measures that will limit outside income for members of the legislature, prohibit payments for legal referrals, better regulate and distinguish between legislator's reelection and housekeeping accounts and enhance openness and disclosure in lobbying funds (A.9535, Heastie). The Assemblyman and his colleagues also again passed a measure co-sponsored by Assemblyman Cahill (A.6975-B, Kavanagh) that would subject Limited Liability Corporations (LLCs) to existing contribution limits for corporations.

In an effort to continue the Assembly's commitment to increase public accessibility of government records, the house also approved an act expanding New York's sunshine laws, some of which have been considered in years past. This package includes bills that would clarify that the automatic and blanket denial to requests for records filed under the Freedom of Information Law (FOIL) is prohibited (A.4468, Englebright), as well as legislation that would require the identity of political committees that pay for political communications to be fully disclosed.

"We owe it to the people of our great state and to each other to work as hard as we can to regain the trust and respect of those who put us in office. I am confident that these measures and our redoubled attention to good behavior and self-policing will be positive steps in that direction," Assemblymember Cahill concluded.

Tobacco Corp's Tax Exempt Revocation Prompts Inquire

The Office of the Ulster County Comptroller has begun an inquiry into the Ulster Tobacco Asset Securitization Corporation (UTASC), after discovering that the blended component unit of the County has had its tax exempt status revoked for failure to file an annual return with the Internal Revenue Service (IRS) for three consecutive years. UTASC, a local development corporation, created pursuant to a local law enacted by the Ulster County Legislature in September of 2000, was originally excused from filing an annual return until being notified by the IRS in 2011 of a change in the law requiring the submission of Form 990. The IRS followed up on January 30, 2013 and May 21, 2013 and issued a notice of revocation on August 18, 2014.

The ongoing issue was highlighted again after an independent audit was submitted in March of 2016 for the year ended December 31, 2015. In the Summary of Significant Accounting Policies it was noted that

"During the year ended December 31, 2014 management received notification from the Internal Revenue Service revoking the corporation's tax-exempt status, effective May 15, 2014. Management is taking the appropriate steps to reinstate the corporation's tax exempt status and believes this determination will be reversed."

UTASC was formed to acquire the future rights, title and interest of millions of dollars of the County's Tobacco Settlement Revenues (TSR) that were a result of a settlement agreement that resolved cigarette smoking-related litigation. According to the most recent audited financial statement, UTASC had general revenues of \$4.266 million for the year "which included approximately \$4.113 million in tobacco settlement revenues (TSR) and approximately \$153 thousand in interest income earned on investments."

According to the IRS website, the penalties for an exempt organization that fails to file could be as high as \$50,000 if that organization has gross receipts in excess of \$1 million for the year.

New Yorkers Should Remain Vigilant During Tax Season (From Pg. 8)

New York State's General Business Law section 372 (known as the Consumer Bill of Rights regarding Tax Preparers), requires RALs to be marketed as loans - not refunds. RACs are temporary bank accounts established on behalf of a taxpayer into which a direct-deposit refund can be received -but these also come with fees that will reduce the consumer's refund. The tax preparer must give the consumer a written disclosure that explains:

- o That consumers are not required to take out a refund anticipation loan or refund anticipation check in order to receive your tax refund;
- o The amount of fees and interest consumers will have to pay for a refund anticipation loan or refund anticipation check;
- o The amount consumers will receive after the fees and interest are deducted;
- o The annual percentage rate of interest that consumers will be charged;
- o The amount the refund will be without a refund anticipation loan.
- o Consumers can avoid the costs of refund anticipation loans and checks by filing their return electronically and having refunds mailed or directly deposited into their own bank accounts.

Consumers may report suspected instances of consumer fraud by calling Attorney General Schneiderman's Office at 1-800-771-7755 or by visiting www.ag.ny.gov.

The Attorney General also reminds New Yorkers that there are Volunteer Income Tax Assistance (VITA) sites where consumers can get their tax returns prepared free of charge. For more information about how to qualify and identify VITA location sites, go to www.irs.gov.

Consumers whose income is \$62,000 or less may qualify for FreeFile and can use free tax preparation and e-filing software. Information on free e-filing is available at: www.tax.ny.gov.
