

House Committee Approves Gibson Lyme Legislation; Tick-Disease Research borne Transparency and Accountability

Act makes critical progress
Washington, DC - Congressman Chris
Gibson (NY-19) announced the House
Energy & Commerce Committee approved H.R. 4701, the Tick-borne Disease Research Transparency and Accountability Act of 2014, constituent-driven legislation addressing a major health threat to the residents of

Upstate New York.

H.R. 4701, which was introduced by Congressman Gibson in May, seeks to prioritize federal research on Lyme and related diseases and give patients a seat at the table. "I am delighted to announce this important milestone in the years-long effort to combat Lyme and tick-borne diseases," said Congressman Gibson. "This legislation is the first standalone bill addressing Lyme disease to pass through a committee in Congress. I deeply appreciate the tireless advocacy and valuable insights of the many citizens who speak out on this issue every day. I also want to thank my neighbors Congressmen Paul Tonko and Peter Welch for supporting this bill. I look forward to its passage by the full House, but my staff and I will not relent in our fight for improved research, treatment, and prevention of this public health scourge."

The bipartisan legislation forms an interagency working group consisting of federal agencies and non-federal partners, including experienced Lyme physicians and patient advocates with a broad spectrum of scientific viewpoints. The working group is tasked with ensuring coordination among federal agencies to maximize research priorities.

H.R. 4701 requires the Secretary of Health and Human Services to consult with the working group to submit a strategic plan to Congress within three years that includes benchmarks to measure progress. The plan must include a proposal for improving outcomes of Lyme disease and other tick-borne diseases, including progress related to chronic or persistent symptoms, infections, and co-infections.

Congressman Gibson thanked the following advocacy groups for their guidance and support: Tick-borne Disease Alliance, Lyme Research Alliance, Partners Against Lyme, Lyme Disease Association, Lyme Disease Society, and Lyme Action Network.

Who Was Black-Eved Susan?

Black-eyed Susans are native to North America and one of the most popular wildflowers grown. They are easily recognized by their yellow flowers with a brownish-purple center that are two to three inches across. The plants can grow to over 3 feet tall, with leaves of 6 inches, stalks over 8 inches long.

Black-eyed Susans are biennial, which means they live for two years. In the first year, the plant grows a rosette, which is a group of leaves growing from the



center, low to the ground. In the second year, the plant sends up flower stalks. At the end of the second year, the plant dies.

Butterflies, bees and a variety of insects move the pollen from one plant to another as they drink the flower's nectar. The mature seeds are very light and move about easily with the wind.

Black-eyed Susans are a pioneer plant, that means they are one of the first

plants to grow in a new field. In a garden, they can crowd out other plants and need to be controlled.

Snails, slugs, and aphids eat the leaves of this plant.

Rabbits and deer eat the entire plant.

The genus name for all Black-Eyed Susans is Rudbeckia. Named for the Rudbecks, a very famous Swedish father and son from Upsala, Sweden. Olof the Elder(1630-1702) was a famous scientist known for his accomplishments in medicine (anatomy) and liguistics. He was also known for studies in botany and established the first botanical garden in Sweden, which was originally called Rudbeck's Garden.

His son, Olof the Younger, (1660-1740) a scientist and professor, continued many of the father's studies. One of his best-known students was another Swedish scientist, Carolus Linneaus, who devised our system of plant nomenclature. It is no surprise that Linneaus gave the name "Rudbeckia" to this important group of plants. A modern descendant of the Rudbecks is Alfred Nobel, originator of the Nobel Prizes. It's safe to say that our lowly, common roadside "weed" has a very prestigious

But who was Black-eyed Susan?

Her story is one of the grand romantic tales of the wildflowers. No one's sure, but the legend says it all comes from an Old English poem of the post-Elizabethan era entitled simply, "Black-Eyed Susan," written by a very famous poet of the day named John Gay, 1685-1732.


#### **Household Hints**







Volunteer firefighters frequently work in the presence of vulnerable individuals, including children. This bill would require prospective volunteer firefighters to authorize a background check for sex offense convictions if the individual wishes to proceed with his or her application. The bill would also allow individual fire companies to determine if the prospective volunteer is eligible to become a volunteer member of such fire company if that person has been convicted of a registerable sex offense is found.
This law passed both houses of the legisla-

ture as S1885C and A2318D, respectively.
Senator John J. Bonacic said, "Volunteer fire department personnel should have all the means necessary to prevent convicted sex offenders from becoming volunteers, and remove any who presently serve. Oftentimes, volunteer firefighters are in situations where children and



UC to Offer Life-Saving Supplies Naloxone and Training to Certified EMS Providers Throughout the

"Heroin use across the United States is an epidemic, as is the abuse and misuse of opiate-based prescription drugs," said County Executive Hein. "What we are doing today may well save someone's life and avert a tragedy. I want to thank Dr. Carol Smith for her expertise and commitment to ensure proper training is readily available, as well as Steve Peterson, acting Director of Ulster County's Emergency Communi-cations/Services Department, for highlighting this issue for first responders within fire departments. I also want to acknowledge Sheriff Van Blarcum and the Police Chiefs Association for taking a leadership role by making sure our law enforcement personnel are already equipped with this life-"We saving device.' have made significant progress in reducing many forms of substance abuse, however, opioid drug abuse, primarily through the misuse of prescription pain killers, is one area that has increased. Overdoses can happen at any time and at any place. With proper training, our first responders can use naloxone to immediately reverse an opioid overdose. This gives our first responders the time needed to get the patient to the hospital for further treatment," said Dr. Carol Smith, Ulster County Commissioner of Health and Mental Health.

"As operators of Ulster County's 911 system, our department generally gets an emergency overdose call first, and every minute counts. The more agencies that have naloxone on board, the greater the chance that we can save a life. Making naloxone supplies and training available to all of our first responders definitely enhance the prospect of a positive outcome," said Steve Peterson, acting Director of Ulster County Emergency Management

Communications.

"I want to thank the County Executive for acting quickly and helping to provide the tools to volunteer fire departments and other first responders that can help us save a life," said Kevin Keller, Chief of Bloomington Fire Department. "I am looking forward to having my members trained and being equipped with this life-saving device as soon

as possible."

"Ulster County is serious about the fight against heroin and opioid abuse and County Executive Hein is being proactive in addressing this epidemic. By making naloxone supplies and training available to first responders, we are supplying them with the tools to save lives," said Wayne Freer, Ulster County's First Fire / Emergency Deputy Coordinator and Director of Public Safety at SUNY Ulster. "This would also be a great asset to have available on the college campus and SUNY Ulster would be interested in having their safety officers participate in these important trainings."

"Working with all EMS responders in the County will have positive effects," said Rich Parrish, Ulster

County EMS Coordinator.

"Ulster County is moving quickly to address the opiate overdose epidemic and I appreciate County Executive Hein's initiative in helping to combat this serious issue," said Cheryl DePaolo, Director of the Ulster Prevention Council, a proof Family Services. "Overdoses lead to over 113 tragic deaths per day nationally, and the number continues to climb.

Administering Narcan as soon as emergency responders are on the scene quickly reverses the overdose and will save lives."

Naloxone is an opioid antagonist that is used to counter the effects of an opioid drug overdose, such as heroin, morphine and prescription painkillers. It acts to counter the lifethreatening depression of the central nervous system, respiratory system and hypotension associated with an

opioid overdose.

In 2013, the New York State Emergency Medical Advisory Committee (SEMAC) approved the use of naloxone by certified Basic Life Support EMS providers in Basic Life Support (BLS) EMS agencies. EMS providers are frequently the first to arrive at the scene of an overdose putting them in the best position to administer this time-sensitive, life-saving intervention. The County Executive's initiative will equip approximately 900 first responders with naloxone kits.

According to the findings of New York State Department of Health's EMS Demonstration Project, as of December 31, 2013, there have been over 2000 EMTs trained throughout New York resulting in 223 opioid drug overdose reversals, with no adverse events and no significant hazards to EMS personnel. Similarly, a 2010 report by the Centers for Disease Control (CDC) estimates that naloxone use and training are estimated to have prevented 10,000 opioid overdose deaths.

In order to participate in the Basic Life Support naloxone program, an EMS agency must enter into an agreement with the County and must have approval from its medical director, complete an approved training and make notification to the local Regional Emergency Medical

Advisory Committee.

Schneiderman Issues Alert and Tips for Consumers in Response to Reports of Massive Online Security Breach -As Law Enforcement Fights Growing Problem, Simple Steps Can Help Keep Consumers Ahead Of Cybercriminals NEW YORK - Attorney General Eric T. Schneiderman today issued reported massive online security breach in which hackers stole over 1 billion unique user names and passwords and half a billion e-mail General addresses. Attorney Schneiderman offered tips to consumers for safeguarding sensitive personal information online. 'As more of our personal data is

being exchanged and stored online, the risks posed to consumers by major security breaches has become all the more critical," said Attorney General Schneiderman. "As law enforcement pursues those who are responsible for these breaches, it is important that consumers remain vigilant. Taking a few key precautions can help keep you a step ahead

of cybercriminals.

This latest breach, perhaps the largest ever of its kind, targeted websites of both large and small companies as well as individuals. It is believed that individuals suspected of being responsible for such breaches sell stolen data to third parties on the black market and use the information to send spam advertisements to consumers.

If you believe that you are a victim of this or any other security

breach, Attorney General Schneiderman offers the following

o Create an identity theft fraud report. To do this, file a complaint with the Federal Trade Commission and print your Identity Theft Affidavit. You can call the FTC at 1-

o Use that affidavit to file a police report and create your Identity Theft

o An Identity Theft Report will help you deal with credit reporting companies, debt collectors and any fraudulent accounts that the identity

thief opened in your name.

o Put a freeze on your credit report by notifying each of the credit (Equifax, reporting agencies TransUnion or Experian). This will block someone from obtaining credit using your name or personal information. You won't be able to apply for any new credit cards or loans while the freeze is in effect, but you can continue to use your existing cards. To freeze your credit file, you must notify each of forces. The Iraqi Air Force - both the three major credit bureaus. You can remove the freeze temporarily or permanently by contacting each of the three agencies. There is no fee if you have been the victim of As a condition of providing that identity theft. The freeze can be removed only by you.

o Get a copy of your credit report from each of the three agencies. You are entitled to free reports once you post a fraud alert (see below) or put a freeze on your account. Read the reports carefully to see whether other fraudulent transactions or accounts are listed, and then take steps to cor-

rect those errors.

 Check your credit card account frequently to look for any irregular

activity.

 Change any user names and passwords. For user names and passwords, change them immediately on the relevant account and monitor the account for unusual activity. If you use the same user name or password on other accounts, change those as well.

If you might be a victim:

o Report to any of the three credit reporting agencies (Equifax, Transunion or Experian) that you may have been a victim of identity theft. Make sure the credit reporting agency has your current contact information so it can get in contact with you.

o Ask the credit reporting agencies to put a fraud alert on your credit file. This will still allow you to use an alert to consumers following a your credit card. If you put a fraud alert on your file, you may ask for a free credit report from each of the credit reporting agencies. Contacting any one of the three credit reporting agencies listed above is enough to file a credit alert with all of them. A credit alert must be renewed every

> o You also have a right to put a credit freeze on your file. You may be charged a fee of up to \$5 if you have not been a victim of identity theft.

> You should also check your credit activity regularly with each credit issuer. You don't need to wait for your monthly statement, though you should check that as well. Many banks provide online information to account holders about recent activity.

The Attorney General's Office also suggests that consumers guard against future threats in the following ways:

o Create strong passwords for online accounts and update them frequently. Use different passwords for

different accounts, especially for websites where you have disseminated sensitive information, such as credit card or Social Security num-

 Carefully monitor credit card and debit card statements each month. If you find any abnormal transactions, contact your bank or credit card

agency immediately.

o Do not write down or store passwords electronically. If you do, be extremely careful of where you store passwords. Be aware that any passwords stored electronically (such as in a word processing document or cell phone's notepad) can be easily stolen and provide fraudsters with one-stop shopping for all your sensitive information. If you hand-write passwords, do not store them in plain

o Do not post any sensitive information on social media. Information such as birthdays, addresses, and phone numbers can be used by fraudsters to authenticate account information. Practice data minimization techniques. Don't overshare.

o Always be aware of the current threat landscape. Stay up to date on media reports of data security breaches and consumer advisories.

#### Governor Cuomo Signs Legislation Expanding Those Responsible for Reporting Suspected Child Abuse

Governor Andrew M. Cuomo today signed legislation to better protect children by adding school coaches to the the field of professionals required to report suspected abuse to authorities. This bill, (S.4751B/ A.421C) will also require coaches who currently hold or apply for a temporary coaching license or professional coaching certificate to com-plete two hours of training regarding the identification and reporting of child abuse and maltreatment.

"This legislation is another step forward in New York's fight against child abuse," Governor Cuomo said. "With the proper training, and the clear mandate to report suspected instances of abuse, school coaches will play a crucial role in keeping our children safe and out of harm's way."

The law had previously been unclear on whether individuals in these positions must report suspected cases of abuse. This legislation clarifies that coaches who are paid employees of a school district have a duty to report suspected abuse. As with all mandated reporters, coaches will be protected from civil liability resulting from reports that are proven unfounded.

Senator Andrew Lanza said, "When a coach witnesses child abuse the crime should always be reported directly to law enforcement authorities. Our law enforcement professionals have the authority, expertise, and resources to investigate and prosecute criminal activity and the sooner they know about allegations of abuse the sooner justice can be done. With this type of crime, delay can mean more victims.

Assembly Member Paulin said, "Coaches are in a unique position of trust with their players, and this law will ensure that if a child confides in their coach or the coach observes signs of abuse, they will report it to the authorities. This will help protect children from abuse."

The commissioner of education will prescribe regulations for this new training. Documentation of the completed coursework will be required to obtain and hold a temporary coaching license or professional coaching certificate, effective July 1, 2015.

Governor Cuomo Announces More Than \$14 Million to Recruit and Educate the Next Generation of Stem Cell Science Researchers-Funding will promote biomedical curriculum in schools statewide

Governor Andrew M. Cuomo today announced that more than \$14 million in funding is available to promote and support stem cell research in New York State. Stem cell science is widely viewed by experts as the key to understanding

and treating many of the most devastating conditions affecting New Yorkers and people worldwide.

Providing teachers with access to advanced learning opportunities is one of the best ways that we can help them empower today's students to become tomorrow's researchers," Governor Cuomo said. "The Empire State is proud to be a leader in many health-related fields, and it is my hope this program will help more New Yorkers define the face of modern medicine for years to come.'

Hands-on stem cell research opportunities will be made available to middleand high-school biology teachers through programs developed by not-for-profit or public colleges and universities. Teachers will spend six-to-eight weeks conducting research in a stem cell laboratory and will carry their experiences back to students in lesson plans or hands-on activities to foster interest in stem cell research.

The funding is available through the New York State Stem Cell Science Program (NYSTEM) and will be invested on the recommendation of the Empire State Stem Cell Board (ESSCB). NYS-TEM administers New York State's stem

cell research enterprise.

The teacher training program aims to increase the supply of future stem cell scientists by offering real-world experience that teachers can share with students who are exploring science and technology as a potential career path. It will also relationships between researchers at academic institutions and middle- and high-school teachers.

NYSTEM will award as many as 30 two-year contracts, totaling up to \$4 million, through this RFA. New York State science museums and science centers that focus on human, animal or plant biology and have a Board of Regents Absolute Charter are eligible to apply. Acting State Health Commissioner Dr. Howard Zucker said, "Programs like these reach students in non-traditional settings and ways, making science more fun. These initiatives blur the line between academics and recreation and make science less intimidating for students of all ages.

Because of the success of the first round of funding, NYSTEM has reissued its Institutional Training program RFA. It supports direct training and career development for aspiring stem cell scientists. Eligible not-for-profit or government institutions may apply for a total of \$7.5 million in funding for up to five years each. NYSTEM will make awards to up to four organizations to support pre-doctoral and post-doctoral fellows. Science (NYSTEM) Program

NYSTEM is New York State's multi-million dollar stem cell research funding program, the second largest in the nation. It works under the guidance of the Empire State Stem Cell Board, whose mission is "to foster a strong

stem cell research community in New York State and to accelerate the growth of scientific knowledge about stem cell biology and the development of therapies and diagnostic methods under the highest ethical, scientific, and medical standards for the purpose of alleviating disease and improving human health." Through NYSTEM, New York State has invested more than \$300 million at 35 New York State institutions for research, infrastructure and education since its inception in 2007.

The Empire State Stem Cell Board was created to advise the New York State Commissioner of Health regarding the NYSTEM program. #### Cuomo Signs Gov Legislation Expanding Those Responsible for Suspected Reporting Child Abuse

Governor Andrew M. Cuomo today signed legislation to better protect children by adding school coaches to the the field of professionals required to report suspected abuse to authorities. This bill, (S.4751B/ A.421C) will also require coaches who currently hold or apply for a temporary coaching license or professional coaching certificate to complete two hours of training regarding the identification and reporting of child abuse and maltreatment.

"This legislation is another step forward in New York's fight against child abuse," Governor Cuomo said. "With the proper training, and the clear mandate to report suspected instances of abuse, school coaches will play a cru-

cial role in keeping our children safe and out of harm's way."

The law had previously been unclear on whether individuals in these positions must report suspected cases of abuse. This legislation clarifies that coaches who are paid employees of a school district have a duty to report suspected abuse. As with all mandated reporters, coaches will be protected from civil liability resulting from reports that are proven unfounded.

Senator Andrew Lanza said, "When a coach witnesses child abuse the crime should always be reported directly to law enforcement authorities. Our law enforcement professionals have the authority, expertise, and resources to investigate and prosecute criminal activity and the sooner they know about allegations of abuse the sooner justice can be done. With this type of crime, delay can mean more victims."

Assembly Member Paulin said, "Coaches are in a unique position of trust with their players, and this law will ensure that if a child confides in their coach or the coach observes signs of abuse, they will report it to the authorities. This will help protect chil-

dren from abuse."

The commissioner of education will prescribe regulations for this new training. Documentation of the completed coursework will be required to obtain and hold a temporary coaching license or professional coaching certificate, effective July 1, 2015.


