Blackberries

The Blackberries are just starting to ripen in Sundown. In some parts of the Catskills they are ready for picking.

Blackberries are one of my favorites, but there is always competition with the birds when it comes to

picking and who gets there first!

The blackberry is an edible fruit produced by many species in the Rubus genus in the Rosaceae family. The usually black fruit is not a true berry. Botanically



it is termed an aggregate fruit, which means the berry is really made up of lots of tiny, round, shiny berries stuck together. Each tiny berry in the cluster has its own seed, so one animal eating one fruit spreads many seeds.

It is a widespread and well-known group of over 375 species.

Blackberries are perennial plants which typically bear biennial stems ("canes") from the perennial root system. In its first year, a new stem, the primocane, grows vigorously to its full length which can be as tall as 9 feet or more, sometimes arching or trailing along the ground and bearing large palmately compound leaves with five or seven leaflets. During the first year it does not produce any flowers. In its second year, the cane becomes a floricane and the stem does not grow longer, but the lateral buds break to produce flowering laterals (side shoots), which have smaller leaves with three or five leaflets. First- and secondyear shoots usually have numerous short-curved, very sharp prickles that are often called thorns.

The fertilized flowers mature into the fruit, which ripens from mid-summer to early fall, changing from green to red then to a dark purple that is almost black.

Unmanaged mature plants form a tangle of dense arching stems, the branches rooting from the node tip on many species when they reach the ground. Vigorous and growing rapidly in woods, scrub, hillsides, and hedgerows, blackberry shrubs tolerate poor soils, readily colonizing wasteland, ditches, and vacant lots, thus today the wild blackberry can be considered an invasive species. Blackberries grow wild throughout all parts of the Catskills.

There is evidence from the Iron Age Haraldskær Woman that she consumed blackberries some 2500 years ago. It is reasonable to conclude that blackberries have been eaten by humans over thousands of

years!

The Native Americans revered the blackberry for its many medicinal properties, and they also made fiber from the stems that was used to make a strong twine. Another use was as a huge barricade around the village made of piles of the thorny canes, for protection from 4 and 2 legged predators. The fruit was also used for purple and blue dyes.

A little bit of folklore tells that you never eat blackberries that are picked after Old Michaelmas Day (11 October). Here's why: When the Devil was kicked out of Heaven on October 11, he landed, cursing and screaming, on a thorny blackberry bush. He avenges himself on the same day every year by spitting on the berries, which makes them inedible. There is some value behind this legend as wetter and cooler weather often allows the fruit to become infected by various molds such as Botryotinia which give the fruit an unpleasant look and may be toxic.

Now is the time if you get a chance, roll down your sleeves (to avoid the thorns) and start picking! Blackberries are very common on state land, along the roadside. Just make sure that you have permission to pick the berries if they are on someone's property

Household Hints

Whiten Your Dingy White Socks

Are your white socks getting a little dingy? To whiten them, start by adding 1 cup vinegar to 1 1/2 quarts tap water in a large pot. Bring the solution to a boil, then pour it into a bucket and drop in your dingy socks. Let them soak overnight. The next day, wash them as you normally would.

What if a UFO landed behind our house? What would we do . . . Yeah. That game. We all do it from time to time and it's not always negative. What if I won the lottery? What if weird old Aunt Wilma died and left us an ostrich ranch in the Australian outback? The WHAT IF game can be entertaining, harmless and fun-providing one doesn't let it get out of hand and become neurotic. For a handful of us, the privileged few who write fiction for a living, the game can be downright intoxicating, because some of our best story ideas come that way.

After I'm Gone, (Wm Morrow/Harper Collins, \$26.99, 334 pages, ISBN 978-0-06-208339-5) by Laura Lippman is a case in point. She, inspired by a real life event that her husband encouraged her to investigate, used her imagination . . . playing the WHAT IF game and turned it into a dandy crime story with her writing talents . . . which are formidable. She is a best-selling author with a world-wide fan base and a slew of novels to her credit. So . . . WHAT IF . . . your spouse or significant other left for work one day and simply disappeared; and you never saw them again. Not ever. And, in addition, making it all the more painful, you never knew where or how, or whatever happened to them. That's the premise of Lippman's novel, which focuses on the life of Bambi Gottschalk and her three young daughters after the disappearance of her husband of fifteen years, a man named Felix, who was about to start a prison term for criminal gambling activity. Although Bambi has no idea where he is, or what happened to Felix, she thinks that his mistress, a woman named Julie does. When Julie disappears ten years to the day after Felix, Bambi's sure that they're together. But then, decades later Julie's remains are found in an overgrown, remote and inaccessible part of a local park. The murder goes unsolved until a cold case detective re-opens it. You'll be fully engrossed by then in the lives of the women Felix Gottschalk left behind, and in trying to figure out which one knows where to find the missing man. Read After I'm Gone, and discover for yourself why Laura Lippman is so wildly popular. You'll love her!

MY SUMMERS IN THE CATSKILLS

I had the pleasure of reading the supplement in the Times Herald Record last week about the resorts and bungalow colonies that were a big part of the Catskills years ago. I started thinking back to the early 1940's when my family spent two summers in Accord, N.Y. and the following are my recollections of the great times we had there.

The winter of 1943 was not a good one for me, I had scarlet fever, the flu and the mumps, one after the other. When I recovered our family doctor said that it would be beneficial for me to get out of the city and "up to the mountains for fresh air and sunshine". I was a scrawny kid to begin with and being ill didn't help matters so plans were made with my Aunt Rose and Uncle Sidney to make the trek up to Sam and Bertha Goodman's dairy farm and boarding house. My parents could not afford a resort or a bungalow colony for a whole summer so this seemed to be their best option.

The trip took almost a whole day as there was no "Quickway", only the slow, very slow way up Old Route 17 through every town, hamlet and village along the way. We went in two cars, both packed to the roof (and on the roof) with every conceivable household item that would be needed to spend a whole summer away. My brother, Matt and I rode in the back seat of my uncle's car and we were surrounded by boxes and bundles of every conceivable size and shape so it wasn't very comfortable. The only stop we made was at the "Red Apple Rest" for something to eat and a bathroom break. My only vivid memory of the place was my uncle drinking a glass of ice cold buttermilk. It was enough to make me gag. Back then I didn't like butter let alone buttermilk and he insisted it was good but was not able to convince me to try it.

We spent many hours in the car and my brother and I were getting bored so my mother suggested we count cows. Back then the countryside was dotted with farms everywhere so we proceeded to look for them and count to pass the time. We finally turned off Route 209 (didn't know what the road was then) and onto a couple of winding side roads and there it was, Goodman's farm and Rooming House. There was a fairly large building that served as bedrooms and bathrooms. Nearby was a separate building which was a communal kitchen and dining room. Across the road was the barn and cows were milling around waiting go be milked.

After we got settled, our summer began. Every morning the women would take a metal pail out to the back door of the farmer's house and there they would get fresh milk that was ladled from a milk can. It was as fresh as you could get, right from the cow and not pasteurized. We then went out to eat in the kitchen building where there were tables and chairs at one end and at the other there were two long counters with cupboards on the bottom and several two-burner gas stoves lined in a row on top. Each family had one stove and the storage space below. When I think about it

now, I am amazed that the women were able to prepare decent meals with that setup but they did.

There were a good number of other families there, all Jewish families escaping the heat of the city. We had many kids of all ages to play with and lots to do. Needless to say, we didn't have TV or a radio but someone did bring up a phonograph and records so we did have some entertainment. Most days we explored the cow pasture, played all kinds of outdoor games and of course, there was swimming.

The Rondout Creek was across the road and through two cornfields and was just a short walk. It was shallow enough for the little kids and the bigger ones could go down a short way to deeper water. It's a good thing that back then we weren't aware that there were copperheads and rattlesnakes in the area. As they say, ignorance is bliss and luckily we didn't encounter any. By the middle of summer the corn was ripe and on the walk back the women would each swipe a few to have for supper. Little did any of us know that corn for cows is not the same as sweet corn for eating. It didn't matter to us, we ate it anyway and survived.

On rainy days we would play board games, read, color and the girls would sometimes have paper dolls. The mothers were pretty inventive and they even had us put on plays.

Every Thursday the women had to get their kosher chicken for the weekend so we would trudge off, kids and all, down to Accord where there was a small building where the chickens were killed (with the Rabbi supervising the procedure). We walked everywhere since we had no other transportation; the husbands took the cars back to the city and they came up after work on weekends. Sometimes we even walked to Kerhonkson and never gave it a second thought. It wasn't until I moved up here that I realized how far that was. Along the way the other girls and I would pick flowers and make bouquets. Queen Ann's lace, black eyed Susan, daisies and anything else that had a blossom on it was fair game.

Mr. and Mrs. Goodman were really nice people and some mornings when he had to take the milk to the creamery, Mr. Goodman would allow a few kids to ride in the back of the pickup with the milk cans and go with him. That was a treat that we all looked forward to and a different group went each time so everyone would have a

One vivid memory that I have is of the black bull that was kept in a separate penned area. To a 7 year old kid he looked huge. The war was on back then and Mr. Goodman, being a patriotic man, named him "G.I." He had a ring in his nose and I thought that was a strange place for a ring. Most of the time he was pretty docile but I now know that looks can be deceiving and he could have gotten pretty ornery if provoked. We enjoyed seeing the cows come in each evening to be milked and sometimes Mr. Goodman would let a bunch of us go out into the pasture to get the cows to come down. Most of the time we were in our bare feet and didn't always miss stepping in a few cow pies. My mother was not too thrilled when Matt and I came in with brown feet. A little hosing took care of the mess in a short time.

The summer always seemed to go by so fast

and the kids hated to go home. Our parents liked it enough that we returned the following summer. As much as I have embraced today's technology and some of the wonderful things that we have that make our lives a bit easier, those years were certainly a simpler time and I have some very nice memories of my summers in the Catskills. Little did I know that many years later that Sullivan County would become my home.







2014 Watershed DEP Releases Recreation Newsletter - Annual Newsletter Provides Updates on Hiking, Fishing, Boating and Other Recreational Activities on City Lands in Upstate Watersheds

The New York City Department of Environmental Protection (DEP) today announced the release of its annual Watershed Recreation Newsletter, which serves as a guide for thousands of people who enjoy outdoor activities on Cityowned land across the upstate watersheds. The 2014 edition includes information about a new rental program that makes recreational boating easier, new hiking trails that have opened in partnership with nonprofit organizations, and information about licensed guides that are now permitted to provide hiking, fishing and other professional tours on Cityowned properties in the Catskills.

"We encourage residents from New York City, the upstate watersheds, and surrounding areas to enjoy the thousands of acres of land and water that DEP has opened for public access," DEP Commissioner Emily Lloyd said. "Whether it's hiking on trails in the Catskills or ice fishing on reservoirs in our Croton System, there are a growing number of ways for people to engage with our water supply and the protected lands that make it one of the best unfiltered water sup-

plies in the world."

The Watershed Recreation Newsletter provides information about the recreational boating program, which has attracted more than 2,500 visitors to the Cannonsville, Neversink, Pepacton and Schoharie reservoirs since 2012. It also includes details about four new hiking trails that DEP is developing in partnership with local hiking organizations and land stewards. Those who regularly use City-owned property for recreation will also find helpful safety tips and information on keeping their free DEP access permits up to date.

There are now 118,000 acres of City-owned land open for recreation in the watersheds, including 84,100 acres of land, and reservoirs that comprise 33,900 acres. Of that, 60,000 acres of land are in public access areas that are open to recreation without a DEP permit.

Gibson Congressman Announces Passage of America Gives More Act H.R.4719 makes permanent incentives for landowners to create conservation easements

Washington, DC - Congressman Chris Gibson (NY-19) announced the passage of H.R. 4719, the America Gives More Act, which includes provisions to incentivize landowners to create conservation easements.

H.R. 4719 makes permanent the temporary deduction for contributions of conservation easements by farmers, ranchers, and families. The bipartisan legislation passed the House of Representatives July 17 by a vote of 277-130.

Conservation easements keep our farmland in cultivation and protect the rural landscape of the 19th District for future generations," said Congressman Gibson. "These deductions have led to a significant increase in the acreage of protected farms and forests across the countryproperties that benefit all of us through their agricultural productivity and natural beauty. I want to thank the many advocates in the Hudson Valley and Catskills who worked hard to advance this common-sense legislation."

Those advocates include Scenic Hudson and the Columbia Land Conservancy (CLC), a not-forprofit organization that helps farmers and landowners around Columbia County conserve rural properties and wildlife habitat.

CLC Executive Director Peter Paden said the conservation language in the America Gives Act "reflects fundamental American values: respect for private property ownership, equality of opportunity, and a commitment to conserve and care for the bountiful but fragile natural world that we inhabit and depend upon for so many of life's

essentials. "Representative Gibson has been a true champion for this and many other conservation initiatives in the House of Representatives," said Mr. Paden. "We are enormously grateful for his lead-ership and dedication."

H.R. 4719 also includes provisions to allow tax-free distributions from IRAs for charitable purposes, among other initiatives to encourage

giving to charitable organizations.



I'M DONALD DAGGETT, 72 YEARS OLD AND I WOULD LIKE TO THANK THE MANY PEOPLE WHO HELPED ME THROUGH THE LAST FOUR AND A HALF YEARS WITH THIS GUN GHARGE THAT I FOUND MYSELF IN AT THE TRI-VALLEY SCHOOL. I HELD A VALID NEW YORK STATE FULL CARRY CONCEALED GUN PER-MIT. AFTER I FOUND THE CARS AT THE SCHOOL THAT WERE RUNNING MY WIFE OFF THE ROAD WHILE WALKING, I GOT THE LICENSE PLATE NUMBERS AND WAS LEAVING THE SCHOOL TO GET THE POLICE THAT I HAD TWICE SPOKEN TO ABOUT MY PROBLEM. I WAS ASKED TO NOT TO GET THE POLICE AND INVIT-ED INTO THE SCHOOL TO SPEAK TO THE PRINCIPAL.I DIDN'T GIVE THE GUN, THAT I ALWAYS CARRY, ANY THOUGHT.I WAS MORE WORRIED ABOUT MY WIFE OR SOME OTHER OF MY NEIGHBORS GETTING KILLED. WHEN I REALIZED THAT I HAD THE GUN ON ME I TOLD THE PRINCIPAL AND GAVE IT TO HIM. HE TOOK THE GUN AND BUL-LETS AND LEFT THE ROOM. THE NEXT THING I KNOW THAT THERE WERE STATE TROOPERS ALL OVER THE PLACE. THE TROOPERS WERE COURTEOUS, RESPECTFUL, PROFESSIONAL AND EXPLAINED EVERYTHING THAT WAS GOING TO HAPPEN. THEY DIDN'T SEEM TO BE THREATENED BY ME AND WE DOKED ABOUT WHAT WAS HAP-PENING. THE BCI TROOPER THAT SAT WITH ME WAS VERY PLEAS-ANT. I WAS NEVER FRISKED OR HANDCUFFED.

NOW DEALING WITH OUR JUSTICE SYSTEM WAS A DIFFER-ENT STORY. I REALLY DON'T THINK THAT THE SULLIVAN COUNTY DA'S OFFICE EVER KNEW OR CARED ABOUT WHAT REALLY HAPPENED. THEY WANTED A CONVICTION NOT THE TRUTH. THEY DID EVERY-THING TO MAKE IT ROUGH FOR ME. I WAS LIED TO, THINGS WERE TWISTED, I WAS THREAT-ENED WITH ARREST IF I EVER APPROACHED EITHER OF THE YOUNG MEN THAT ALMOST RAN OVER MY WIFE, I WAS THREATENED WITH ARREST IF I WAS CAUGHT ON MOORE HILL RD A PUPLIC ROAD THAT RUNS BETWEEN THE SCHOOL THE FOOTBALL FIELD AND THE TRACK.

PAPERS WERE LOST AND I WASN'T ALLOWED TO SEE THE TRANSCRIPT OF WHAT WAS SAID WHEN I MADE A DEAL WITH THE ASSISTANT DA IN ROSCOE, NY. THE ASSISTANT DA HERE IN MONTICELLO TOLD THE JUDGE UNDER OATH THAT I DIDN'T DESERVE A NEW YORK STATE FULL CARRY CONCEALED GUN PERMIT. Summer - In Sullivan And Orange Counties 5,863 low income Kids Ate Lunch Daily In The Summer While Almost 21,748 Ate Lunch Daily During The School Year

Monticello, NY - Standing at the YMCA Camp in Thompson Town Park, U.S. Senators Kirsten Gillibrand, joined by New York State Assemblywoman Aileen Gunther and Chef Andrew Yeomans announced the bipartisan Summer Meals Act, which would enhance the U.S. Department of Agriculture (USDA) Summer Food Service Program. The legislation would help improve nutrition and enhance learning in underserved areas by better integrating summer education and meals programs, making it easier for publicprivate partner organizations to participate in the summer meals program, and by providing a third meal for children who attend

evening enrichment programs. "Many children receive their only meal at school during the year, and when school is out for the summer, they go hungry," said Senator Gillibrand, first New York Senator to serve on the Senate Agriculture Committee in nearly 40 years. "The bipartisan Summer Meals Act would help combat this problem by strengthening the USDA summer nutrition program to help more children across America access quality meals during the summer months. Every child who is hungry should have food year round."

"Summer meals programs are more important than ever, especially in my District where food insecurity is an issue facing far too many children," said New York State Assemblywoman Aileen Gunther. "No child should ever go hungry, and the Summer Meals Act of 2014 is a welcome and necessary measure to ensure that every child has access to nutritious food during the summer months. I'm proud to stand with Senator Gillibrand and support passage of this critical legislation."

"Senator Gillibrand's attention to this issue and the development of this program will be such a welcome benefit for the children of Sullivan County, " said Scott Samuelson, Chairman of the Sullivan County Legislature. "The County's health ratings and poverty numbers make this area the perfect choice to begin to expand this program. We thank the Senator for her forward thinking and great compassion."

"We are pleased to welcome Senator Gillibrand to the Town of Thompson," said Thompson Town Supervisor William J. Rieber, Jr. "We commend the Senator on her initiative to ensure that our young children are provided with healthy and nutritious meals during the summer break. Our children are our future. No one should go hungry in this great country."

"The Summer Food Service Program's residual benefits not only provide meals when school is not in session, but it provides entire families a modicum of financial relief by leaving more grocery money available for wholesome foodstuffs currently experiencing significant cost increases," said Chef Andrew Yeomans, Food Service Director of the Monticello Central School District, "This program's residual benefits also include but are not limited to, targeting Federal dollars to areas experiencing significant numbers of low income families by closing the widening gap between food insecurity and food security, providing an alternative revenue stream to many school nutrition programs currently operating in a negative financial position thereby lessening the burden on local property taxpayers mandated to cover the balance. Further, as demonstrated by Monticello Central School District's program, community organizations will utilize USDA's SFSP as a "Draw" for participation, which pulls children from potential inactivity, or mischief, gives them organized activities to participate in, and fosters a healthier lifestyle through physical activity and the development of healthier eating habits."

"When this school year ended, over 1.5 million low-income children throughout New York lost access to school meals, an increase of nearly 38,000 students from the previous school year who qualified for a free or reduced-price school meal," said Linda Bopp, Executive Director of Hunger Solutions New York. "This bi-partisan bill will increase access to summer nutrition for low-income kids and teens while effectively addressing hunger and meeting increased need. It is in our best interest to ensure that these children have adequate nutrition during the summer so they stay healthy, active and return to school in the fall ready to learn."

Across the country, 31 million students participate in the national school lunch program, and 22 million students receive free or reduced school lunch - meaning their families lives at or near the poverty line - but only one in seven of these high need children have access to summer meals. In New York, there are more than 1.7 million children who receive free or reduced school lunch, but only 27 percent have access to summer meals.

On a typical school day in March 2013, there were 17,676 students in Orange County who participated in the free or reduced priced school lunch program. In Sullivan County there were 4,072 students and in Ulster County there were 6,723 students. However, in July 2013, there were only 5,055 children in Orange County, 808 in Sullivan County, and 373 in Ulster County who participated in the summer lunch program.

The Summer Meals Act would help more children access healthy food by lowering the threshold to allow areas with 40 percent or more of students receiving free or reduced lunch to be eligible for the program. Currently the bar is set at 50 percent. Senator Gillibrand's legislation would expand eligibility to an additional six Sullivan County school districts: Liberty, Fallsburg, Sullivan West, Eldred, Livingston Manor, and Monticello.

This legislation would also reduce the paperwork burden for private-public partnerships who want to participate in the program, provide children with transportation to the summer meals sites, and would also offer an additional meal to children who attend evening programs.

The USDA Summer Food Service Program provides low-income children under age 18, who would normally receive free or reduced school lunch, with quality, nutritious food during the summer. Several programs run in tan-dem with educational enrichment programs to keep children engaged and safe during the summer months. Currently, there are 45 national organizations that have endorsed the Summer Meals Act legislation.



Notice of Availability of Environmental Assessment Report Regarding Neversink Ballfields and Town Park Improved Project, Town of Neversink, Sullivan County, NY FEMA-4020-

Notification is hereby given to the public of the intent of the Department of Homeland Security-Federal Emergency Management Agency (DHS-FEMA) to provide Federal financial assistance to New York State Division of Homeland Security and Emergency Services (NYSDHSES), as Grantee, and the Town of Neversink, New York, as Subgrantee, for an improved project for the reconstruction of the Neversink Ballfields and Town Park at a new location in the Town of Neversink, Sullivan County, New York. The new Baseball fields and Park would replace the function of the facility located on Sundown Road, Town of Neversink, which sustained flood damage during Hurricane Irene. The storm incident period of August 26, 2011 to September 5, 2011 was declared a major disaster by President Obama on August 31, 2011 (FEMA-4020-DR-NY) and subsequently amended. Federal public assistance was made available to affected communities and non-profit organizations in accordance with the Robert T. Stafford Disaster and Emergency Assistance Act of 1974 (Stafford Act), 42 U.S.C. 5121 et seq., as amended. FEMA public assistance would provide funding for the proposed action, which would fully restore all services disrupted by flood damage to the original facility.

The proposed project involves construction of a new Town park and ballfields on property purchased by the Town of Neversink for this purpose at 7752 NYS Route 42 and an adjacent parcel (no street address is assigned). Currently, both parcels are vacant, although 7752 NYS Route 42 had recently contained a single family residence that the Subgrantee demolished in preparation for this action. The other parcel had been used as a hayfield. The new facility would include associated site improvements, such as an access road (driveway), parking areas, infrastructure upgrades, and stormwater management systems. The new facility would be located outside the 100-year floodplain.

In accordance with the National Environmental Policy Act (NEPA), an Environmental Assessment (EA) has been prepared to assess the potential impacts of the proposed action on the human environment. DHS-FEMA's requirement of addressing floodplain management and wetlands protection in accordance with 44 CFR Part 9 is incorporated with the EA. THE \$24 MILLION INSURANCE BILL Positive Changes Await County Self-Insurance

.Upon completion of a Health Benefit Dependent Eligibility Audit, Ulster County Comptroller Elliott Auerbach provided a call to action for the Legislature and Administration with recommendations to safeguard a multi-million dollar county expense.

The Report summarizes an audit by Auerbach's Office which sought to verify the eligibility of employee dependents. All Ulster County employees are eligible for health care coverage. Employee dependents, however, are only eligible if they meet certain criteria.

The Comptroller's report highlighted the importance of the issue by citing several major factors:

1) Ulster County spent \$24.7 Million on healthcare benefits in 2013; 2) Ulster County covers over 4000 enrollees; 3) Ulster County's cost per participant ranges from \$662-\$2492 each; 4) Ulster County lacks adequate procedures to document dependent eligibility;

The Comptroller's recommendations call for a collaborative effort that includes:

 An annual verification of dependent records;
 An update of current records; and 3) Legislative policy as to verification requirements and corresponding standards of operating procedures adopted by the Administration
