**“Jack” Will Make his Regal Appearance**

It is that time again when we will begin to see the other "Jack" is back in the neighborhood. Now that the cold winter weather is finally behind us, we know that it is not Jack Frost, but instead, Jack in the Pulpit! Taking a tour of the backyard this weekend with the kids, grandkids and great grandkids, we saw all kinds of amazing things in the forest. But a favorite, Jack-in-the-Pulpit, seemed to stand out every here and there. Right now if you are out in the woods you should



begin to see the full plant with Jack who will look like a Sunday-morning preacher ready to deliver his sermon from his lofty pulpit. Or, you may just see the young see only the trifoliate leaves on a young plant.

This native plant, also called Indian turnip, is unmistakable in our moist woods. Jack-in-the-Pulpit enjoys growing in open glades in the forest in rich, moist soil. They are an herbaceous perennial growing from a corm with trifoliate leaves with a flower contained in a spadix, or club, covered by a striped hood reminiscent of an old-fashioned pulpit.

A Jack-in-the-Pulpit (*Arisaema triphyllum*) is classified in the Arum family (Araceae) along with skunk cabbage and the calla lily. It grows from 12-18" tall from an underground stem or corm. In spring it sends up a stout stem that looks like a green candle which unrolls into two three pointed leaves and a flower stalk.

Tiny white flowers cluster around a finger-like shape that we call Jack (spadix) and a leaf-like canopy arches over the spadix. This pulpit (spathe) is striped with maroon and green or white and green. Some botanists say this is due to sunny or shady conditions during growth. The darker striped Jacks are found in shady deep woods and light Jacks in open locations, however, you may often find both growing side by side, which tends to make you think that sunlight isn't the only determinant deciding the coloration factor.

The two large green, compound, long-petioled leaves (1-1.5' long), divided into three leaflets each, emanate upward from a single stalk and provide umbrella-like shade to the flower. The fleshy stalk and leaves lend an almost tropical aura to the plant. Flowering plants initially produce only male flowers, but become hermaphroditic as they mature over the course of several years. Male flowers are on the upper part of spadix and female on lower part. Most plants in a colony will vanish by mid-summer and become dormant, but the mature, hermaphroditic flowering plant will expose a cluster of green berries as the pulpit dries up and drops off. Toward the end of summer the berries will ripen and become bright red and will be quite visible. Birds and animals find the berries to be a tasty treat.

American pioneers learned from the Native Americans to look for this distinctive plant in spring in moist eastern woodlands. They called it Bog Onion. They also learned that the bulb was poisonous when eaten raw but became a safe, spicy delicacy when cooked.

In the spring, when the bear come out of hibernation they will root out and eat Jack-in-the-Pulpit as the irritating peppery bulb expands the bear's shrunken bowels to normalcy.

According to some Native American tribes, this plant was initially thought to be a great 'diagnostic' tool. The seeds were often dropped into small pools of water, and if they floated, then the patient would survive; if they sank, however, then the patient would get sicker or even die.

A preparation of the root was reported to have been used by Native Americans as a treatment for sore eyes. Preparations were also made to treat rheumatism, bronchitis, and snakebites. One report on "Indian Turnips" claims the Meskwaki Indians, the "people of red earth" of Algonquian origin, used the acrid seeds to poison their enemies during the heat of battle. They would poison their meats with the seeds!

On your next woodland walk, I hope you find one of these uncommonly pretty flowers. With care, they can be transplanted to your garden. Or, there is another choice - you can now order a Jack-in-the-Pulpit from an on-line wild-flower catalog!



The novel opens in Los Angeles. It's August of 1962 and the city is sweltering in a relentless heat wave that has residents ready to explode.



## Rent Relief Program Offers Support for Tenants and Landlords

After a significant delay by the Cuomo administration, beginning today June 1, 2021, the Emergency Rental Assistance Program (ERAP) is finally open for moderate and low-income applicants seeking financial support with their monthly housing payments, facing homelessness or utility shutoffs. New Yorkers are eligible for the stipend if their household income is at or below 80 percent of the Area Median Income (AMI), they have received unemployment benefits or loss of income on or after March 13, 2020 and are currently in rental arrears.



ERAP will cover up to 12 months of missed payments and in certain circumstances three months of forthcoming rent, provided directly to the property owner. Tenants and landlords alike can seek assistance and there is no deadline for applying, as the program is set to run until funding is exhausted.

“This initiative will provide much-needed relief for those who have lost income during the COVID-19 Pandemic and can be a lifeline to responsible landlords too. I encourage renters requiring assistance to apply and urge property owners to inform struggling residents of this opportunity,” said Assemblymember Kevin A. Cahill (D-Ulster, Dutchess).





## New York's Eighth Annual Invasive Species Awareness Week Begins Sunday, June 6

*Free Public Events Scheduled Across New York State  
ISAW Kicks Off with Webinar Highlighting Events  
and New York's Invasive Species Network*

The New York State Departments of Environmental Conservation (DEC) and Agriculture and Markets (AGM) today announced that the state's eighth annual Invasive Species Awareness Week (ISAW) begins this Sunday, June 6. Free public events and invasive species challenges are offered from June 6 - 12 across the state and online, including daily webinars at 1 p.m. and 7 p.m. Governor Andrew M. Cuomo issued a proclamation designating ISAW to support the annual campaign to encourage New Yorkers to learn more and participate in the fight against the negative impacts of invasive species.

"Each year, Invasive Species Awareness Week provides an excellent opportunity for New Yorkers to learn about invasive species and how they can get involved to help protect our forests, grasslands, lakes, rivers, wetlands, and other natural areas from the negative impacts of invasive pests," said DEC Commissioner Basil Seggos. "Anyone can be part of the solution and help to reduce the spread of invasive pests by making simple changes to everyday activities."

"Invasive species like the spotted lanternfly pose a great risk to some of New York's leading crops, like apples and grapes, in addition to our horticulture and forest industries," said State Agriculture Commissioner Richard A. Ball. "Learning how to identify and report this pest and others will help us in limiting their spread and managing their negative impacts. I encourage everyone to get involved this Invasive Species Awareness Week and help to protect New York's precious natural resources."

Invasive species are plants, animals, insects, and pathogens that are not native to an area and cause harm to the environment, agriculture, economy, or public health. New York is particularly vulnerable to these pests due to its role as a center for international trade and travel.

### **Scheduled events include:**

Statewide webinars about reporting invasive species, community engagement, and simple steps everyone can take to prevent the spread of invasive species;

Guided hikes and floating classrooms to learn how to identify different invasive species;

Webinars demonstrating how to landscape with native species; and

Volunteer events to take part in invasive species removals.

Anyone interested in participating in an ISAW event, including the daily webinars, is encouraged to visit the New York Invasive Species Awareness Week Events webpage to find a complete list of offerings in their area. The Sunday, June 6, webinar will highlight the events scheduled for ISAW 2021 and discuss New York's collaborative invasive species network that includes Partnerships for Regional Invasive Species Management, or PRISMs.

Everyone can make a difference in the fight against invasives by helping to locate and map infestations, using only local firewood, properly cleaning watercraft before and after boating, cleaning dirt off boots after hiking, or removing invasive species from the yard. 

Prepare brownie mix batter according to package directions. Spread 2 cups into a greased 13x9-in. baking dish; set aside.







## Martucci, Gunther Pass Bill Helping Sportsmen, Protecting Animal Welfare

### *Legislation Expands the State's Yearling Buck Protection Program in the Members' Districts*

Albany, NY - Senator Mike Martucci (R,C,I-Hudson Valley and Catskills) and Assemblywoman Aileen Gunther (D,WFI-Forestburgh) announced two-house passage of legislation that will expand protections for yearling bucks in a substantial portion of the Catskills, S5694 and A6182. The bill will soon be sent to the Governor for his signature.

“The New York State DEC's yearling buck protection program is overwhelmingly popular and viewed by sportsmen in my district as beneficial to both hunters and the local deer population,” said Senator Martucci. “I am proud to sponsor this legislation and I am pleased to work in bipartisan fashion with Assemblywoman Aileen Gunther, on behalf of our shared constituency, to support this commonsense conservation effort and make it law.”

The bill formalizes into statute existing Department of Environmental Conservation (DEC) policy which holds a mandatory antler point restriction (AR) in select wildlife management units (WMUs) in Southeastern New York. The WMUs aided by the Senator's and Assemblywoman's bill are 3H in Sullivan and Ulster counties and 3K in Sullivan and Orange counties. All towns within the boundaries of WMUs 3H and 3K are represented by Senator Martucci in the 42nd Senate District, with the vast majority located in Sullivan County and also represented by Assemblywoman Gunther in the 100th Assembly District.

“As Chair of the New York State Legislative Sportsmen's Caucus, I am proud to have sponsored this important bill in the Assembly. Our sportsmen overwhelmingly support the yearling buck protection program, and its continued success is vital for our area. I want to thank Senator Martucci for his partnership and for getting this bill passed in the Senate,” said Assemblywoman Gunther.

The Federation of Sportsmen's Clubs in Sullivan County, Inc. had requested this legislative safeguard for the yearling buck protection program after seeing its success. The program restricts hunters to harvest adult male whitetail deer (bucks) with at least 1 antler with 3 or more points that are at least 1 inch long. The purpose of the program is to reduce the number of yearling (1.5-year-old) bucks that are harvested, allowing them to reach full maturity and creating a healthier, more diverse deer population overall. The program also allows for a more challenging hunting environment for prospective hunters, one that they enjoy and encourage.

“The Federation of Sportsmen's Clubs of Sullivan County would like to thank Senator Mike Martucci for his tireless efforts on Senate Bill S5694, which adds WMUs 3H and 3K to the Yearling Buck Protection Act,” said John S. Van Etten,



# New York State Emergency Rental Assistance Program

- The applicant owes past due rent at their current residence.



"Through this historical marker, we are enshrining the service and sacrifice of our brothers, fathers and neighbors into the most contemplative and picturesque road in the State. As millions of families travel through the Catskills to enjoy our natural wonders, they will be granted the opportunity to reflect on this period in our history," said Assemblymember Cahill.

The ideal justice proceeds in a measured fashion, is fair, balanced, and objective, but who also has the ability to serve a community effectively by understanding the community's history, needs, and culture. ## The SC Sheriff's Office Concludes 3 month investigation Into Street Level Narcotics sales in the Monticello, Liberty and Jeffersonville Areas

On Wednesday May 26, 2021, the Sullivan County Sheriff's Office Gang and Narcotics Intelligence Unit executed a search warrant at 28 Taylor A Road in Jeffersonville (Town of Delaware). The location, which is on a quiet dead end road, is alleged to have been a distribution point for a large portion of the heroin that is trafficked in Sullivan County. At the location Deputies seized over 500 bags of heroin/fentanyl, a quantity of



crack cocaine, suboxone strips, packaging materials, a scale and \$3400 in US Currency. Further investigation led deputies to two additional locations; 564 Willi Hill Road in White Sulphur Springs where 7 ounces of heroin/fentanyl was recovered and 313 Cooks Brook Road in the Delaware County town of Colchester were approximately \$11,000 in US Currency was seized.

As a result of the execution of these search warrants, the following 8 suspects were arrested:

Carlos Colon, 30, of Liberty - charged with Criminal Possession of a Controlled Substance 2nd degree - a Class A-II felony, 3 counts of Criminal Possession of a Controlled Substance 3rd degree, a class B felony, Criminal Sale of a Controlled Substance 3rd degree, a class B felony and Conspiracy 4th degree, a class E felony.

The defendant was sent to the Sullivan County Jail without bail.

Salvatore Heinrich, 33, and Richard Patterson, 27, both of Jeffersonville where each charged with 2 counts of Criminal Possession of a Controlled Substance 3rd degree, a class B felony, Criminal Possession of a Controlled Substance 4th degree, a class C felony, and Conspiracy 4th, a class E felony. Heinrich was remanded to the Sullivan County

Jail without bail. Patterson was released on his own recognizance.

Alanna Bierstine, 32, of White Sulphur Springs was charged with Criminal Possession of a Controlled Substance 3rd degree,

a class B felony. Bierstine was released on her own recognizance.

Alex Eschenberg, 34, of Callicoon, Stephen Mootz, 37 of Callicoon Center and Aaliyah Garcia, 18, of Jeffersonville where charged with Loitering 1st, a class B Misdemeanor. All 3 suspects were issued appearance tickets and released.

Carlos Ortiz, 24, of Liberty was arrested for 2 counts of Criminal Sale of a Controlled Substance 3rd degree, a class B Felony. Ortiz was released on his own recognizance.

Sheriff Mike Schiff described the defendants as "participants" in a network of Sullivan County drug distribution, with Carlos Colon of Liberty as the head of this particular organization. "The product that Carlos Colon sells makes him a purveyor of death and despair", said the Sheriff noting that the overdose rate in Sullivan County is "off the charts". Colon was out on bail, awaiting sentencing for a previous drug conviction when he was arrested on the new charges.

District Attorney Meagan Galligan said, "While Sheriff Schiff and I have promised to seek help for those whose addiction has not yet endangered others, we intend to identify, investigate and hold responsible those who prey upon addiction for profit". Galligan said that the investigation was a result of an ongoing, coordinated effort by law enforcement against the opiate crisis in Sullivan County.

The Sheriff's Office was assisted by the Sullivan County District Attorney's Office, who prepared the search warrants, U.S. Homeland Security Investigations, the Delaware County Sheriff's Office, the Town of Colchester Police Department and the Village of Liberty Police.


