Advocates Speak at Fallsburg Central School

On March 10, 2023, Fallsburg Central School welcomed back speakers Kirby Jones, Eric Kussin, and David Hymowitz to share their positive mental health messages during the Superintendent's Conference Day. This was their second visit to the school this year alone.

Kirby Jones is a Master Instructor for Handle With Care, an advocacy organization that provides behavioral training services for schools, healthcare facilities, juvenile programs, and families. He is also a certified health, safety, and security trainer for the state of New Jersey and a volunteer coach for the Special Olympics. Above all, he is a fierce advocate for the well-being of children. Kirby stressed the importance of addressing the needs of students. Kirby's message focused on the idea that providing nourishment, love, and safety is crucial to building trust and a strong relationship with a child.

Giles Dexter Harlow III (Chip)



passed away peacefully at home in McLean, VA on March 14. He was a part-time summer resident of Claryville. He was born April 14, 1958 to then

Lt Giles D. Harlow, Jr., USAF and Ann Q. Harlow, in Lubbock, Texas. He was the oldest of four children and spent his childhood moving around the country with his military family. He graduated from Langley High School, McLean, VA in 1976 and received a BS in Finance from Clemson University where he was also a Division 1 swimmer and a member of Sigma Nu. While there, he also received his commission in the U.S. Air Force through the ROTC Program. He followed his father's footsteps by earning his USAF pilot wings in Lubbock, Texas at the same base of his birth. He embarked on a USAF career flying C-130s in the Philippines and Germany. He finished his military career as a Lieutenant Colonel with the Wyoming Air National Guard, where he deployed to the Middle East for Operation Iraqi Freedom. Simultaneously, an American Airlines pilot, he spent 34 years travelling the world, enlightening the lives of countless travelers, ensuring their safety, and sharing adventures with his family. As a Boeing-777 Captain, he was set to retire next month.

Chip was well known for his service to country, family and friends. He always sought to do for others in their time of need, providing companionship, assistance and advice. The most accomplished chef of the extended family - a passion of his - Chip was known to be the consummate host and entertainer of friends, family, and welcome guests into his home. He was a thoughtful, nurturing caretaker for people and animals alike. Chip would say his greatest achievement and joy was being a devoted husband and father to his family, making their lives his priority.

He is survived by his wife Jennifer and children Hannah, Sarah and Matthew of McLean, Virginia; mother Ann Q. Harlow of McLean, Virginia; brother Douglas Harlow (Julia) of Falls Church, VA; sister Elizabeth Harlow Morley (Frank); sister Sarah Harlow Pooler (Todd) of Fort Collins, Colorado; father-in-law James Zavatchen of Cleveland, Ohio; and his beloved nieces and nephews and extended family. Burn Ban Now in Effect Statewide

Monticello, NY - With the New York State Burn Ban starting today and running through May 14, Sullivan County Fire Coordinator John Hauschild is emphasizing the fact that open burning isn't just illegal - it's incredibly dangerous.

"The snow cover remains, but vegetation is still dry and easily set aflame by sparks and ash," he explained. "I'm urging everyone to avoid open burning and the consequences that can come with it: callouts of local fire departments, damage to plants and properties, and injuries - even death."

Catskill Mountain Wild Cats

Friday night there was a visitor in Sundown! A huge Bobcat was sizing up the chickens and maybe our pet cats, too.

Our 4 yearold grand daughter excitedly told me how she heard the cat *scream like a witch* as her father chased it up the hill away from the chicken coop and their house.

The bobcat (*Lynx rufus gigas*) a/k/a Wildcat, is a North American mammal of the cat family Felidae, first appearing during the Irvingtonian stage - around 1.8 million years ago. Currently they still live in wooded areas of the Catskills.

Bobcats are about two to three times the size of a domestic cat. Their fur is dense, short, and soft and is generally shorter and more reddish in the summer and longer and more gray in the winter. Spotting occurs in some bobcats and is faded in others. The face has notable long hairs along the cheeks and black tufts at the tops of each ear.

Males on the average are one-third larger than females. Both female and males can weigh more than 30 pounds. Body length for males is 34 inches and 30 inches for females. They have short tails between five and six inch long - thus the name 'bobcat'.

Bobcats are not often sighted in the Catskills as they are stealthy creatures that are timid and typically avoid human contact.

Do not let their relatively small size fool you. They are tremendously strong and can bring down a small deer. They can become ferocious when challenged. It is wise not to approach a bobcat. However, while there is still snow on the ground, you may find their tracks. The average foot print is around 1.75 inches, but can be as large as 3 inches. The prints will have 4 roundish paw prints in front with a "M" shaped paw print in back of the 4 front paw prints. Most prints will not show claws. Like, domestic cats, Bobcats need to use their muscles to extend their claws.

Bobcats are nocturnal and most active from sunset to near sunrise when they are hunting.

Bobcats are carnivores. Their diet consists mostly of rabbits, rats, mice and small wild game. Bobcats easily adapt whatever prey is available. They will stalk their prey and swiftly move in once the prey is within 20 feet. Bobcats can leap up to 12 feet high.


Bobcats live near areas where there are rock ledges and small caves or near swampy areas. They are territorial. They choose an area of a few square miles that has enough prey to feed on, however, they can travel up to 50 miles a day.

It takes a bobcat about two years to mature to breeding age. They mate between February-and-March and have 2-4 kittens between April and May. On occasion they have a second brood in September. The kittens are born blind and won't see until they are around 10 days old. The female bobcat raises its kittens alone and nurses them for about two months before teaching them how to hunt. They remain with their mothers the first year. After that, they will live in the wild for the next 6 to 8 years. The oldest recorded bobcat in the wild lived to be 16 years old!

Bobcats were very abundant in the Catskills until the 1800's when they were hunted - almost to extinction. Today, we are seeing a moderate increase in the population of bobcats.

Bobcats are incredibly beautiful creatures that exist in varied colors from orange to gray with black markings similar to a domestic tabby cat.

Bobcats are often noted as the inspiration of the region's name - the Catskills!

According to Dwight, one of my retired cop buddies, only a few crime fiction writers *Really get it*, when writing about the demands, the stresses and the effect –on marriages, children and personal lives –of being a police officer in America today. It's a career that is rewarding, exciting, sometimes monotonous, and always dangerous enough to take your breath away. Not many outsiders can even begin to understand what it's like to bear the weight of a badge and a gun, much less write about it. But, lucky for us, there are a few who do.

The Force, (Wm Morrow/Harper Collins, \$27.99, 479 pages. ISBN 978-0-06-266441-9) by Don Winslow has been drawing rave reviews from all who've read it, including the Mysterious Book Report. If ever a novel was destined to become the defining work of its genre and a never-to-be-forgotten classic, this is it.


All Denny Malone ever wanted to be was a good cop. He's an NYPD Detective Sergeant, a highly respected, brave and decorated cop who works a drug, gang and murder infested part of the city as the leader of *Da Force*, an elite unit with unrestricted authority to go after the gang-bangers, drug slingers and gun-runners in Manhattan North, also known as Harlem. They're handpicked, the best of the best, resourceful, bright, tough and the princes of Manhattan North. 



Saint Patty's day always conjures up my years in New York City in the 80's, when every bus, every subway car, every street is filled with revelers...most extremely drunk and it doesn't matter the time



of day. I can't help thinking that here, everyone is driving cars and I rarely venture out. I broke that tradition this year.

If you've not been to the TANGO CAFÉ in Hurleyville, it was the first 'Manhattan vibe' café to open in this area. Lots of glass, chrome and a comparable

menu. As you come in, you are greeted as if you are an old friend. And they have music from time to time, which is how I became acquainted. Saint Patty's evening was POISON LOVE, the

trio turned duo for the night of JOANNE WASSERMAN BRINKERHOFF and her husband DAN BRINKERHOFF, which was fitting because what's better to celebrate with than a guitar and a fiddle!



Missing was percussionist SAMMY ALEXANDER. This is a band I do not see enough of, usually because they perform a lot in the western part of the county close to where they live. There is something so 'feel good' about their music! Their sets are comprised almost completely of original music and these originals are great 'story' songs, which, if you truly listen, you will invariably find something that resonates and be as hooked as I am. If I see them three times during the summer, I'll hear three completely new sets of songs. JOANNE is the prolific songwriter, putting observation of the life around her into a song. Last time I saw them, she was also the principal vocalist. That too has shifted. It was DAN who did most of the singing, his voice very reminiscent of an early NEIL YOUNG (ala Harvest Moon). AND he is also a marvelous artist, his chosen medium is wood.

From 'feel good' music to "feel good" music.

The first time I encountered THE OTHER BAND was at DAVE and TERESA TRESTYN'S venue THE HEARTBEAT MUSIC HALL OF GRAHAMSVILLE. I had approached sax man GREG FISKE as he was setting up and asked him the name of the band. When he told me, I thought he was kidding. In fact I thought they were a 'pick up' band. Maybe they were. Maybe I should ask (duh).



The one thing they are is great fun! They have great fun with each other on stage and

with their audience which automatically make everyone 'feel good.' This, however, takes nothing away from their musicianship. When I first saw them back in December, it was JESSIE NORMAN who did most of the singing while playing the bass, which I know from my late husband, who also did this, is not an easy thing to do. The bass guitar and drums set up the



rhythm of the song whereas the vocals are the other end of the scale. Two completely different things. JESSIE took the lead vocals on several songs as did drummer DAVE MUCCI. As did keyboardist DANA

GABRIELSEE. Guit-artist JAMES RATNER, who one can say IS the lead vocalist has a unique timber to his voice that I haven't quite figured out yet, which makes it intriguing. And GREG FISKE on sax (saxophone). Well, there is none better.

Classic rock never sounded so good. THE OTHER BAND is a band you need to get out to see!

And I saw them at the 17 WEST BREWERY on Sullivan Street in Liberty. This was the first time I had been there though my musician friends have been telling me about it since it opened in November of last year. Why? Live music is a big part of what they serve there! There's even a 'fluttery' banner out front proclaiming this to be fact! I am all for any inclusion of music into a business! The entrance is in the back, so keep that in mind.



The interior is cozy and the band was set up in an area enclosed by some sort of special plastic just off the main area. I have to say I had my doubts, having 'lizard blood' (which means I'm perpetually cold) but what a surprise. I was totally comfortable. And owners MICHAEL and TINA are two very gracious people, allowed me to take a picture of their drinks menu (which includes a nice white wine for people like myself who don't drink beer). I will be returning here, for the music yes, and to find out more about this unique place.

Stay safe, stay well and I refuse to say the magic word (spring) in case it makes that storm we didn't get angry and it turns around and comes back.



- 1 (11 ounce) can mandarin oranges, juice reserved
- 1 (16 ounce) package frozen whipped topping, thawed
- 1 (5 ounce) package instant vanilla pudding mix
- 1 (20 ounce) can crushed pineapple with juice

Beat the eggs, and add them to the boxed cake mix. Add the oil and the mandarine oranges to the batter; remember to add the juice as well as the fruit. Pour the batter into a greased and floured 9 x 13 inch pan.

Bake the cake for 40 minutes in a preheated oven at 325 degrees F (165 degrees C). Cool on wire rack.

While cake is baking, prepare the frosting by mixing together the whipped dessert topping, the package of instant pudding, and the crushed pineapple with its juices. Set frosting in refrigerator to set. Frost when cake has thoroughly cooled.







EPA, DEC and Tuscarora Nation Team Up to Combat Illegal Tire Dumping on Indigenous Lands

Public Awareness, Heightened –Enforcement Will Highlight Campaign to Protect Indigenous Lands From Illegal Tire Dumping

The U.S. Environmental Protection Agency (EPA), New York State Department of Environmental Conservation (DEC), and the Tuscarora Nation announced today a partnership aimed at combatting illegal tire dumping on sovereign Nation lands. Documented recurrences of tires and other waste dumped illegally on Tuscarora Nation lands spurred action to prevent ongoing illegal behavior and prompted this joint federal, state, and Nation government-to-government partnership that will help protect the public health and natural resources.

"The partnership between the Tuscarora Nation, EPA, and DEC is considerable progress in the right direction as we collectively move toward the goal of protecting our land and the health of our community," said Rene Rickard-Printup, the Tuscarora Nation's environment director for the Haudenosaunee Environmental Task Force. "For many years, illegal dumping activities have been a burden on the Tuscarora Nation but now we have the support of EPA and DEC to address this issue with businesses and individuals outside our Nation. We are grateful to the EPA for providing some financial support to curb the amount of roadside dumping through barriers to stop illegal dumping, signs to prevent illegal dumping, and cameras to catch illegal dumping. We are also grateful for the support of DEC. Businesses and individuals need to know that, while the Tuscarora Nation is a sovereign, the Nation can and will authorize DEC to take legal action against illegal dumping on the Nation territory."

"Illegal tire dumping is a violation of the law and a threat to public health," said EPA Regional Administrator Lisa F. Garcia. "Together, EPA, DEC and the Tuscarora Nation will increase enforcement on these sovereign lands to the fullest extent of the law and educate the public on the importance of proper tire disposal, safeguarding public health and the environment."

"Illegal tire dumping is hazardous to the environment because waste tires can leach toxins into land and water, threaten public health by creating breeding grounds for mosquitoes and other pests, and are aesthetically displeasing," said DEC Commissioner Basil Seggos. "Dumping tires on the sovereign lands of Indigenous peoples, already disproportionately affected by environmental pollution, is particularly disturbing. DEC law enforcement officers are strictly enforcing illegal tire dumping-including on Nation land where authorized to enter-and violators will be held accountable to the full extent of the law to ensure public health and the environment are protected."

The Tuscarora Reservation is located in Niagara County, approximately 10 minutes outside of Niagara Falls and 20 minutes from Buffalo, and is home to more than 1,000 Tuscarora Nation citizens and their Iroquois relatives and guests. The Tuscarora Nation is neighbor to several Western New York communities and through the Tuscarora Environment Program works to ensure the territory is free from contamination from off-site sources, in accordance with their own laws and traditions.

This Nation-federal-state partnership includes increased enforcement by DEC Environmental Conservation Police Officers of illegal tire dumping, in addition to a public outreach and education campaign aimed at waste tire generators, including area automotive repair facilities, to reinforce the importance of properly disposing of waste tires and reporting improper dumping.

Waste tires are regulated wastes and, by law, must be managed by an authorized facility. Dumping waste tires, or arranging for an improper disposal, are crimes under the New York State Environmental Conservation Law (ECL) that could result in jail time and fines.

Anyone with information about those responsible for the illegal disposal of tires is encouraged to immediately report the incident and location to DEC Environmental Conservation Police at 1-844-DEC-ECOs.




Ulster County Executive Jen Metzger and Municipal Leaders Demand Federal Action to Improve Rail Safety

KINGSTON, NY - Ulster County Executive Jen Metzger sent a letter today to the Department of Transportation (DOT) Secretary Pete Buttigieg and Federal Rail Administration (FRA) Administrator Amit Bose demanding stronger regulations of the freight railroad industry that would improve safety for communities that host rail corridors like Ulster County. County Executive Metzger was joined by 13 Mayors and Supervisors who signed on to the letter, including leaders of the seven municipalities in Ulster County that host railroad lines.

In the letter, County Executive Metzger wrote “rail infrastructure is inadequately maintained and presents unacceptable risks and hazards. Over the years, our communities have documented many concerning conditions, including unsafe bridges, dilapidated crossings, and dangerous track conditions.” Metzger goes on to write that “At a time when railroad companies are reporting record earnings, the lack of investment to protect public health and safety is unacceptable.”

The letter seeks comprehensive action on many fronts, urging the FRA and DOT to strengthen safety standards on tank cars, require electronic braking systems, implement derailment detectors, enact minimum safe staffing levels, increase minimum fines on bad actors, improve the safety of at-grade crossings, increase funding for equipment and training for local first responders, and providing advance notice when hazardous materials are being shipped through the county.

Thirty-eight miles of West Shore Rail Line run through seven municipalities in Ulster County, including through the most densely developed urban cores, and 13 miles of track are located on the shores of the Hudson River. On an annual basis, more than 25 million tons of freight, including crude petroleum, waste, industrial chemicals, motor vehicles, and other goods and materials are transported through these communities. Nearly 200 trains pass over 30 at-grade rail crossings every week in the county.

Modeled after 911, the new three-digit 988 Suicide & Crisis Lifeline is designed to be a memorable and quick number that connects people who are suicidal or in any other mental health crisis to a trained mental health professional.

"If you are willing to turn to someone in your moment of crisis, 988 will be there," said Xavier Becerra, the secretary of the federal Department of Health and Human Services, at a recent press briefing. "988 won't be a busy signal, and 988 won't put you on hold. You will get help."

The primary goal of the new number is to make it easier for people to call for help. Lawmakers and mental health advocates also see this launch as an opportunity to transform the mental health care system and make care easily accessible everywhere in the United States. The Biden administration has invested more than \$400 million in beefing up crisis centers and other mental health services to support the 988 system.

Ulster County Executive Jen Metzger to Donate Pay Raise to SUNY Ulster Scholarship Fund

KINGSTON, NY - Ulster County Executive Jen Metzger has signed a Local Law passed by the County Legislature to provide salary increases to County elected officials including the County Legislators, Clerk, Sheriff, Comptroller, and Executive. County Executive Metzger announced today that she will donate the increase in the Executive's salary to the SUNY Ulster President's Challenge Scholarship fund, which assists at-risk college-bound high school students with a two-year, tuition-free, community college education upon their graduation from high school and enrollment at SUNY Ulster.

"I'm not in public service for the money," said Ulster County Executive Jen Metzger. "I do this work because I want Ulster County to become a sustainable, resilient, thriving community that leaves no one behind, and donating my raise to support a good community college education for our high school students contributes to this broader goal."

County Executive Metzger will be required by law to collect the additional portion of the Executive's salary and pay taxes on that income. County Executive Metzger has committed to donating the after-tax value of the raise to sponsor a student through the President's Challenge Scholarship (PCS) fund at a level of \$7,200. Any remaining funds will be donated to the PCS General Fund, which helps create additional educational and experiential programming for all students enrolled in the PCS program.

Like County Executive Metzger, SUNY Ulster President Dr. Alison Buckley is serving in her first year leading the college. Dr. Buckley is a lifelong advocate for removing barriers to college education and is also a personal donor to the PCS, sponsoring a student in the program with her husband Dr. Mark Evans.

"We are honored and grateful for County Executive Metzger's support of student scholarships and the President's Challenge Scholarship program at SUNY Ulster," said Alison Buckley, Ed.D., 7th President, SUNY Ulster. "Her gift will remove obstacles to make the dream of college a reality for families here in Ulster County, including having a long-lasting impact for generations to come. Thank you to County Executive Metzger for all she is doing to serve the residents of Ulster County and to all of our Ulster Community College Foundation donors who comprise our amazing community supporting the power of public higher education. We cannot allow a price tag to be the barrier to a college degree."

Lorraine Salmon, Executive Director of the Ulster Community College Foundation said, "Thank you to County Executive Metzger for changing a life through our President's Challenge Scholarship program. Her gifts to this program are intended to support a scholarship for a student and student experiences for some of the nearly 300 high school students who, as of June 2023, will have been awarded scholarships for this program since its inception."

The PCS program has set a goal of providing scholarships to 50 students in 2023. Director Salmon said that County Executive Metzger's pledge marks the 45th sponsorship this year, and she is hopeful that this donation will spur other local leaders to become donors and help the fund reach, and even exceed, its goal. The Ulster County Legislature passed Local Law Number 13 (LL13) of 2022 at the body's February 14, 2023 meeting. The law was prompted by the work of the Ulster County Periodic Compensation Review Committee, a committee required and established by the Ulster County Charter, which reviews the salaries of all elected officials of the County of Ulster at least every other year.

According to the language of LL13, "the most recent Periodic Compensation Review Committee was constituted, as the Charter requires, by multiple appointing authorities, and met several times to conduct a thorough review. In furtherance of its duties, the Committee held a public hearing on March 14, 2022. At the close of the Committee's review process, the Committee filed a Recommendation Report on March 24, 2022." The new salary levels are reflective of the recommendations made by the Periodic Compensation Review Committee in their 2022 report.

Local Law 13 will be effective for 2023, and will increase salaries as follows:

In addition to its ranking for maple production, New York is also home to the largest resource of tappable maple trees within the United States and more than 2,000 maple sugar makers. In 2022, New York's maple industry used 2.9 million taps, tying 2021's record for the largest number of taps used in a single year. The New York State Department of Agriculture and Markets supports the maple industry through the New York State Budget—which includes funding for promotion and educational programs—as well as through investments in research projects, such as Cornell University's Maple Program's Arnot Teaching Forest, and through its NYS Grown & Certified and Taste NY marketing programs.

Throughout the month of March each year, and, in particular, during the weekends of March 18-19 and 25-26, maple farms across the state open their doors to the public to provide a chance to taste pure maple syrup, right from the source, and experience the unique family tradition of making maple syrup in New York State. Producers, including many of those that are NYS Grown & Certified, offer tours and pancake breakfasts, sell maple products, and demonstrate the syrup-making process, which includes the traditional system of hanging buckets on trees or more modern methods of production using vacuum systems to increase the yield of sap per tree. Maple Weekends in 2023 will take place at nearly 150 maple sugarmakers' farms, boosting agri-tourism across New York State. DEC Announces 2022 Bear Harvest Totals

Overall Harvest Declined Slightly; Harvest Density Greatest in Catskills

New York State Department of Environmental Conservation (DEC) Commissioner Basil Seggos today announced that New York bear hunters harvested an estimated 1,318 black bears during the 2022 hunting season. As in past years, the Catskill region recorded the greatest bear harvest densities.

"New York's black bear populations remain robust, particularly in the Catskill and Adirondack regions," Commissioner Seggos said. "Regulated bear hunting is a necessary tool for population management, especially with numbers increasing in recent years. I'm pleased to see hunters across the state logged another successful and safe bear hunting season."

Hunters harvested an estimated 458 bears in the Northern Zone and an estimated 860 bears in the Southern Zone, an increase of about 14 percent in the north compared to the previous year and a decrease of approximately nine percent in the south. The total bear harvest was approximately 10 percent fewer than the five-year average. As in past years, the Catskill region produced the greatest bear densities. In Wildlife Management Units (WMUs) 3C, 3H, 3K, 3M, and 4R, hunters took more than 10 bears per 100 square miles, with hunters taking more than 15 bears per 100 miles in WMU 4R.

11.8: the number of bears harvested per 10 square miles in the town of Port Jervis, Orange County, which had the greatest bear harvest density of any town.

520 pounds: the heaviest dressed-weight bear reported to DEC in 2022, taken in the town of Windsor, Broome County, WMU 7S. Scaled weights of dressed bears were submitted for 26 percent of bears taken in 2022.

612: the number of hunter-harvested bears in 2022 from which DEC collected teeth to determine the bear's age.

Black bear harvest data are gathered from two main sources: harvest reports required of all successful bear hunters; and the physical examination of bears by DEC staff and cooperating taxidermists. Harvest estimates are made by cross-referencing these two data sources and determining the rate at which hunters report bear harvests in each zone. In 2022, 80 percent of successful bear hunters in the Northern Zone and 89 percent of successful bear hunters in the Southern Zone reported their harvest. In the fall of 2023, DEC will send a 2022 Black Bear Management Coordinator Patch and a letter confirming each bear's age to all hunters who reported their bear harvest and submitted a tooth for age analysis.

DEC's 2022 Bear Harvest Summary report provides tables, charts, and maps detailing the bear harvest around the state. Past harvest summaries are also available on DEC's website. DEC's Black Bear Management Plan (PDF) provides information on how DEC determines black bear population objectives throughout the state.

Gillibrand, Capito Announce Bipartisan, Bicameral Legislation to Support Families of Individuals Struggling with Substance Use Disorder

WASHINGTON, D.C. - Today, U.S. Senators Kirsten Gillibrand (D-NY) and Shelley Moore Capito (R-WV) announced their bipartisan, bicameral legislation to provide families with the tools they need to support their loved ones living with addiction. The Family Support Services for Addiction Act would provide \$25 million in grant funding to help nonprofits and community organizations provide support services to families with loved ones seeking addiction treatment. The House version of this bill is led by Representatives David Trone (D-MD-6) and Daniel Meuser (R-PA-9).

"Equipping families with the resources they need to support loved ones battling addiction and substance use disorder is essential for recovery. Unfortunately, getting support can be difficult as people face stigma, a lack of insurance coverage, racial disparities, and an inability to pay for support services," said Senator Gillibrand. "My Family Support Services for Addiction Act would deliver \$25 million in vital funding for financially strained mental health care and substance use disorder support programs and ensure resources are available to families helping people recover from substance use."

"The past few years have been tough on all of us, but especially for those in addiction treatment and recovery, as well as their families," Senator Capito said. "This bipartisan legislation will hopefully provide family members with the support, resources, and information they need to assist both their loved ones struggling with substance use disorders and all within their family who are impacted by it."

"My nephew, Ian, died of a fentanyl overdose after struggling for years with mental health and substance use disorders. I know full well how difficult it is for families to find accessible, affordable care - all while trying to get through the day," said Congressman Trone, co-chair of the Bipartisan Mental Health and Substance Use Disorder Task Force. "The Family Support Services for Addiction Act recognizes the toll substance use disorder takes on families and equips them with the knowledge, guidance, and support to best help their loved ones suffering from this disease. We must never forget that we're all in this fight together."

"Obtaining services for those struggling with addiction and their loved ones shouldn't compound an already difficult situation," said Congressman Meuser. "The Family Support Services for Addiction Act will offer relief to families by providing federal aid to community organizations that assist in navigating insurance coverage, exploring treatment options and understanding how to get an individual on the path to recovery. After passing the House last Congress, I am eager to join Congressman Trone to introduce this important legislation again in the 118th Congress."

"Addiction is a disease that affects the entire family and when family members are involved in their loved one's care and recovery, outcomes are better. The Family Support Services for Addiction Act will create a grant program to support local organizations that provide services and supports to families impacted by addiction. In the midst of an unrelenting addiction crisis, it is critical to invest in families who are supporting a loved one struggling with addiction." - Creighton Drury, CEO, Partnership to End Addiction

"Faces & Voices of Recovery fully supports the Family Support Services for Addiction Act. This legislation will provide much needed guidance and resources for families to navigate systems that are often confusing and challenging. To be as effective as possible, recovery from addiction requires a network of support. Families

play a crucial role and by engaging families with recovery community networks we will build a stronger foundation for all our recovery efforts." -Patty McCarthy, Chief Executive Officer, Faces & Voices of Recovery

Health care providers and hospitals across New York are still dealing with the impacts of the COVID-19 pandemic, and the number of patients needing treatment for substance use disorders continues to rise. According to the CDC, there were an estimated 107,622 drug overdose deaths in the United States during 2021, an increase of nearly 15% from the 93,655 estimated deaths in 2020. Even before the pandemic, families with individuals who have a substance use disorder often struggled to access basic support services. Even when services are offered, they often come at an additional cost.

Fortunately, research shows that outcomes can improve when family members are involved in a loved one's treatment. The Family Support Services for Addiction Act would establish a federal grant program to help nonprofits and community organizations offer support to families of individuals struggling with substance use disorder. This bill would also bolster national and local community programs that offer family support services by delivering \$25 million in grants through the Department of Health and Human Services over five years. Family support services include caregiver peer support, education and training, systems navigation for families trying to access treatment and other resources, counseling services, support groups for those in crisis and for those who have lost loved ones, and skill-building.

Senator Gillibrand Visits the Monticello VA Clinic to Highlight Implementation of Pact Act and Help Veterans Exposed to Burn Pits Access New Benefits It Is Estimated That 3.5 Million Individuals May Be Eligible To Claim New Health Care Benefits

SULLIVAN COUNTY - Today, U.S. Senator Kirsten Gillibrand, Congressman Marc Molinaro (NY-19), Assemblymember Aileen Gunther, Sullivan County Manager Joshua Potosek, and Sullivan County Legislator Luis Alvarez visited the Monticello VA Clinic to highlight the implementation of the recently passed Sergeant First Class Heath Robinson Honoring our Promise to Address Comprehensive Toxics (PACT) Act of 2022. Passed in 2022, the PACT Act included Gillibrand's signature legislation to establish a presumptive service connection to certain illnesses for service members and veterans exposed to burn pits and other toxins, eliminating many obstacles they have to go through to receive crucial health care and benefits. It is estimated that roughly 3.5 million military personnel could have been exposed to burn pits and are eligible to receive benefits.

During her visit, Gillibrand and staff members helped veterans exposed to burn pits learn how they can access and apply for these new benefits.

"When the PACT Act was signed into law, it created one of the most significant benefits expansions in VA history," said Senator Gillibrand. "Today, I'm visiting the Monticello VA Clinic to ensure our vets across Sullivan County have the information and assistance needed to take full advantage of these new health care and disability benefits. I fought tooth and nail to secure these benefits and now my office is here to help make the implementation process of the PACT Act as smooth as possible."

"As a grateful nation, we have a solemn duty to care for our veterans and provide them with the support they need to lead healthy, fulfilling lives. That's why, I applaud the enactment of the Honoring our PACT Act, which expands VA healthcare and benefits for veterans who have been exposed to burn pits, Agent Orange, and other toxic substances during their service. These brave men and women put their lives on the line to defend our freedom, and it's our responsibility to ensure they receive the care and assistance they need to cope with the long-term effects of their service." -Congressman Marc Molinaro (CD 19)

"The PACT Act has had an immediate and profound impact on our local veterans, with our Veterans Service Agency having already assisted in the filing of 47 claims to date," affirmed Sullivan County District 6 Legislator Luis Alvarez, chair of the County Legislature's Veterans Committee. "Additionally, interest in this benefit has brought younger veterans to our offices, allowing us to make them aware of the other services we offer. I thank Senator Gillibrand and her colleagues for their unwavering and active support of our veterans, their families and the people who serve them." -Sullivan County Legislator Luis Alvarez

"I want to thank Senator Gillibrand for coming today to discuss the PACT Act with our local Veterans and community leaders. I have been a tireless advocate for veterans throughout

my time in the Assembly, and believe we need to ensure that we provide them the healthcare they deserve. Our veterans put their lives on the line to protect us, and it is only fair that we as a nation take care of them when they return home. I am proud to see the Pact Act is doing just that, and I look forward to helping our local veterans access this care." - Assemblymember Aileen Gunther

Applying for Benefits FAQ

1. How can I submit a claim?: Eligible veterans exposed to burn pits, Agent Orange, and other toxic substances can submit a claim at [VA.gov/PACT](https://www.va.gov/PACT).

2. What if I was previously denied?: The PACT Act expanded eligibility for VA health care and benefits, so even if you were previously denied coverage, you may now be eligible. Submit a supplemental claim to get the health care and benefits you deserve at [VA.gov/PACT](https://www.va.gov/PACT).

3. Who is covered under the new law?:

1. Veterans who served in Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, or the UAE on or after Aug. 2, 1990

2. Veterans who served in Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, or Uzbekistan on or after Sept. 11, 2001

4. What illnesses are covered?: A wide range of cancers and respiratory illnesses are covered, including: asthma diagnosed after service, head cancer of any type, neck cancer of any type, respiratory cancer of any type, gastrointestinal cancer of any type, reproductive cancer of any type, lymphoma cancer of any type, lymphatic cancer of any type, kidney cancer, brain cancer, melanoma, chronic bronchitis, chronic obstructive pulmonary disease, constrictive bronchiolitis or obliterative bronchiolitis, emphysema, granulomatous disease, interstitial lung disease, pleuritis, pulmonary fibrosis, sarcoidosis, pancreatic cancer, chronic sinusitis, chronic rhinitis, and glioblastoma.

5. What benefits can I expect to be covered?: Just like the Vietnam veterans who fell ill from their exposure to Agent Orange, under this law, anyone deployed to one of the 16 identified countries during the Gulf War and Global War on Terror (listed above) who falls ill with one of the listed conditions will be able to go to the VA and get a disability rating. Depending on the rating, the veteran may be eligible for disability compensation. They are also entitled to free VA health care for their illness.

Senator Gillibrand first introduced her bill, the Presumptive Benefits for War Fighters Exposed to Burn Pits and Other Toxins Act, in September 2020, alongside a bicameral group that included Representative Raul Ruiz (D-CA), comedian Jon Stewart, activist John Feal, and a strong coalition of veterans service organizations. The group introduced an updated, bipartisan version in the spring of 2021 with Senator Marco Rubio (R-FL) and Representative Brian Fitzpatrick (R-PA). In May 2022, Senate Veterans' Affairs Committee Chairman Jon Tester and Ranking Member Jerry Moran announced a bipartisan deal on toxic exposure legislation, the Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive Toxics (PACT) Act. Gillibrand's Presumptive Benefits bill formed the cornerstone of the presumptive care section of the final package. The final bill passed the Senate by a vote of 86-11 and was signed into law by President Biden on August 10th, 2022.

NYS Office for the Aging and the Association on Aging in New York Seeks Input for Master Plan for Aging

If you are 60 years of age or over please complete the survey by March 30

The NYS Office for the Aging and the Association on Aging in New York are working with the research firm Polco on the state's first-ever community assessment survey of older adults. They initiated the survey in preparation for their Four-Year Plan. But the survey results will also make an enormous contribution to the state's Master Plan for Aging (MPA).

In the first phase of this process based on a randomized sample, select households in Sullivan County (among others) were mailed a printed survey or a post card to fill out the survey electronically.

A Union, New Jersey man has been arrested in connection with a wide ranging credit card fraud scheme

On January 18, 2023, a Parksville resident contacted the Sheriff's Office to report that a fraudulent \$296 charge for fuel was made to his credit card at a Mirabito gas station in Norwich, NY. Working with the Chenango County Sheriff, the

Madison County Sheriff and the New York State Police, deputies were able to identify a subject driving a red Volvo tractor trailer with a disguised tank mounted in the bed of the semi-trailer. The investigation revealed that the complainant's credit card number had been copied in the Liberty, NY area and then re-written to a gift card which was used by the thief. The suspect would go to gas stations that did not yet have chip readers on



their pumps and swipe the counterfeit cards containing the stolen credit card numbers using the card's magnetic stripe. The suspect reportedly pumped thousands of gallons of diesel fuel which was then transported to the state of New Jersey where it was apparently sold on the black market. In February, Sheriff's Detectives identified the suspect as Yosiel R. Linares, 30, of Union, NJ and obtained a warrant for his arrest. Soon after, the suspect was arrested by Union Township Police as a

fugitive from justice. On March 2, 2023, Linares was extradited from New Jersey to Sullivan County and arraigned in the Town of Liberty Court. Under the New York bail reform laws, Yosiel Linares was released on his own recognizance pending a future court date. The Sheriff's Office is working with the other law enforcement agencies to identify other suspects that may be involved in this case. The investigation is continuing.

SC Federation for the Homeless Receives Stewart's Grant

The Sullivan County Federation for the Homeless has received a \$1500.00 grant from Stewart's "Holiday Match" program. Stewart's has been collecting and matching donations in their shops from Thanksgiving to Christmas since 1986. Half of all monies collected and disbursed comes from their customers.

In keeping with the parameters of the grant, the Federation will use this money to supplement the bi-weekly food pantry which directly supports children and families in the Sullivan County community. Kathy Kreiter, Program Administrator at the Federation notes that this generous donation comes at a critical time. "Food insecurity is a very harsh reality for many folks living in Sullivan County. Once again Stewarts has stepped up to support our community, and we thank them from the bottom of our hearts."

The Sullivan County Federation for the Homeless is committed to developing individualized and community wide plans for disadvantaged people to break the cycles of poverty that cause homelessness and hunger. 

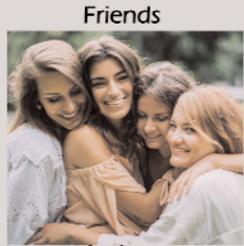

GRANTS CORNER

REMINDER! Applications are open for:

The Department of Justice opened the applications for numerous grants for its Community Oriented Policing Services (COPS) program to hire community police, develop and test innovative policing strategies, and provide training and technical assistance to community members, local government leaders, and all levels of law enforcement.

The Industrial Demonstrations Program opened grants funded by the Bipartisan Infrastructure Law to accelerate decarbonization projects in energy-intensive industries and provide American manufacturers a competitive advantage in the emerging global clean energy economy.

Environmental Justice Thriving Communities Grantmaking program is funded by the Biden Administration's Inflation Reduction Act and will invest in America and expedite investments to reduce pollution in disadvantaged communities. EPA plans to award cooperative agreement(s) to pass-through entities (referred to as Grantmakers by the program) who will collaborate with EPA to design and build their own processes to receive and evaluate competitive community project applications from communities for EJ Thriving Communities Subgrant activities. These activities consist of assessment, planning, and/or project development activities addressing local environmental and/or public health issues. Grantmakers will provide EJ Thriving Communities Subgrants (i.e., subawards) to Eligible Subrecipients. Due May 31.

The Preparing for Active Shooter Situations (PASS) Program is designed to meet the goal of the 2016 Protecting Our Lives by Initiating COPS Expansion (POLICE) Act in offering "scenario-based, integrated response courses designed to counter active shooter threats or acts of terrorism against individuals or facilities."

The program will fund a provider who can provide nationwide training to at least 20,000 first responders over the course of the award through scenario-based, multidisciplinary training classes. The training should be available to any jurisdiction in the U.S. and delivered in the desired location of the requesting agency, to include law enforcement, fire, and emergency medical services (EMS).

Local Agriculture Market Program (LAMP) grants with USDA support the development, coordination, and expansion of direct producer-to-consumer marketing; local and regional food markets and enterprises; and value-added agricultural products. Due May 2.

Rural Energy for America Program Renewable Energy Systems & Energy Efficiency Improvement Guaranteed Loans & Grants provides guaranteed loan financing and grant funding to agricultural producers and rural small businesses for renewable energy systems or to make energy efficiency improvements. Due March 31.

Fiscal Year (FY) 2023 Urban Agriculture and Innovative Production (UAIP) Competitive Grants Program will support the development of urban agriculture and innovative production. Due March 27.

Drug-Free Communities (DFC) Support Program provides grants up to \$125,000 per year for five years to community coalitions to strengthen the infrastructure among local partners to create and sustain a reduction in local youth substance use.

Assistance to Firefighters Grants (AFG) to meet the fire-fighting and emergency response needs of fire departments and non-affiliated emergency medical service organizations.

The Environmental Justice Collaborative Problem-Solving (EJCPS) Program will provide \$30 million in funding directly to community-based nonprofit organizations. Due April 10.

The Environmental Justice Government-to-Government (EJG2G) Program will provide \$70 million in funding to state and local governments to partner with community-based nonprofit organizations. Due April 10.



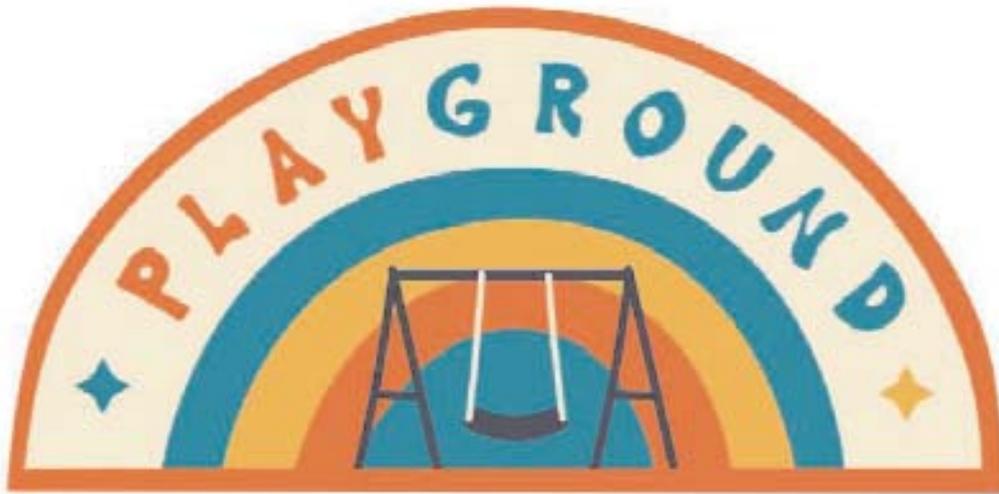

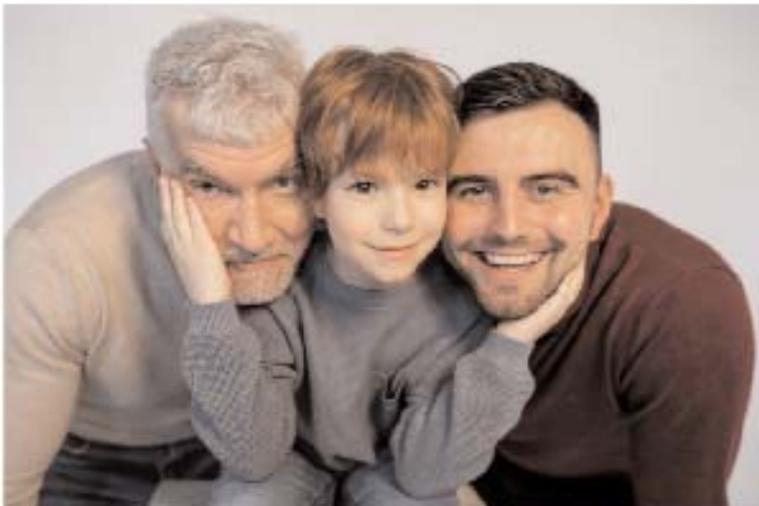

Ending Zuckerbucks & Securing our Elections

As co-chair of the Election Integrity Caucus, I reintroduced the “End Zuckerbucks Act” in the 118th Congress this week. In the 2020 election, Mark Zuckerberg, under the guise of the Center for Tech and Civic Life (CTCL)-a liberal non-profit group-flooded left-leaning county governments in Texas, Ohio, Nevada, Minnesota, Georgia, Florida, Arizona, and Pennsylvania with opaque private funding to influence election administration for their own purposes.

It’s Time to Defund and Leave the WHO

Since the beginning of the pandemic, the WHO has proven that it does not have America’s best interest at heart. Through the disguise of the WHO, millions of taxpayer dollars have bankrolled the Chinese Communist Party’s propaganda and have covered up the pandemic’s origins. The WHO is not reformable.

I recently co-sponsored three pieces of legislation to defund and leave the WHO:

First, H.R.79, the “WHO Withdrawal Act,” led by Rep. Andy Biggs (AZ-5), requires the President of the United States to remove the U.S. from the WHO and prevents taxpayer dollars from being used to fund the organization. This legislation would codify President Trump’s decision in 2020 to leave the WHO, which was reversed by President Biden.

Second, H.R.343, the “No Taxpayer Funding for the World Health Organization Act,” led by Rep. Chip Roy (TX-21), would avert any assessed or voluntary contributions from the United States to the WHO.

Finally, S.444, the “No WHO Pandemic Preparedness Treaty Without Senate Approval Act,” introduced in the House by Rep. Tom Tiffany (WI-7), deems any final agreement on pandemic prevention, preparedness, and response to be a treaty. Under Article II, Section 2 of the U.S. Constitution, treaties require the consent of two-thirds of the U.S. Senate. This bill will prevent the Biden Administration from circumventing the Senate and arbitrarily deeming any final treaty an “executive agreement” which does not require Senate approval.

It is a privilege to join these three pieces of legislation to ensure the United States leaves this CCP-puppet agency.

Amid Nationwide Workforce Shortage, Molinaro Introduces Bipartisan Bill to Help Local Small Businesses Fill Job Openings

U.S. Rep. Marc Molinaro (R, NY-19) today announced the introduction of the Small Business Workforce Pipeline Act. This bipartisan bill will relieve the workforce shortage for local small businesses by assisting them in offering apprenticeships and on-the-job training opportunities for their workers. Rep. Molinaro introduced the bill alongside U.S. Reps. Jason Crow (D, CO-06), Maria Salazar (R, FL-27), and Shri Thanedar (D, MI-13).

At the end of 2022, there were over 11 million unfilled jobs in the United States. The Small Business Administration's Small Business Development Centers (SBDCs) currently provide a suite of counseling and training services to support small businesses in Upstate New York and across the county. To help small businesses fill open positions with qualified workers amid the workforce shortage, Rep. Molinaro's bipartisan bill directs SBDCs to establish and improve apprenticeship and training programs.

Rep. Molinaro said, "Small businesses in Upstate New York have open jobs, but are having difficulty filling these positions. We need to tackle the workforce shortage by connecting workers to the open jobs we have. That's why I'm introducing the Small Business Workforce Pipeline Act. This bipartisan bill directs the Small Business Development Centers (SBDCs) to inform small businesses about apprenticeship and work-based learning programs."

Rep. Crow said, "I introduced the Small Business Workforce Pipeline Act to ensure Colorado remains a strong small business state by investing in apprenticeships and on-the-job learning opportunities for our workers. This bipartisan legislation would bring more opportunities for our workers to reskill and upskill and combat the labor shortage that holds our small businesses back."

- o Accepted artwork includes paintings (including oil, acrylics and watercolor), drawings (including pastels, colored pencil, pencil, charcoal, ink, and markers), collage (must be two dimensional), prints (including lithographs, silkscreen, and block prints), mixed media, computer generated art, and photography.
- o Artwork must be submitted with a completed copy of the competition release form to one of Rep. Molinaro's district offices no later than Monday, April 10, 2023.

DEC Announces 2023 DEC Camping Reservation Changes *New Features Include Same-Day Reservations, Among Others*

The New York State Department of Environmental Conservation (DEC) today announced changes to reservations at DEC campgrounds for the upcoming season, including new same-day reservations to help add flexibility and ease to last-minute bookings.

"DEC is excited to make some changes and updates to this year's reservation window for DEC campgrounds," said DEC Commissioner Basil Seggos. "While many campers book weeks or months in advance, there continues to be a high demand for last-minute bookings. Adding same-day reservations will allow our customers to check availability and book a reservation on their way to a campground. An additional 17 hours to book a camping stay will ensure sites are available before arriving and prevent anyone from arriving to a full campground."

The change will afford last-minute campers the security of a reserved campsite at any of DEC's 52 campgrounds and aligns the Forest Preserve-based campgrounds with the reservation window currently employed by the facilities operated by the State Office of Parks, Recreation and Historic Preservation. All New York State campgrounds will now accept reservations as late as the same day.

Reservations will be required, and patrons can now book a camping reservation as late as 5 p.m. on the desired day of arrival. The public will also be able to book a one-night stay for the 2023 season at any DEC campground beginning April 7, 2023. This will mean that gaps between reservations will be able to be filled earlier than in the past.

Environmental Conservation Police on Patrol

Duck, Duck, Ticket - Ulster County

On Feb. 25, ECO Johnson received a Snapchat video from a colleague showing an individual on film sneaking up on two ducks swimming in a pond and firing four shots from a gun, killing the ducks. With waterfowl seasons for the region closed, Officer Johnson went to the subject's residence, which is also the location of the shooting, to conduct an interview. The subject admitted to shooting the ducks while a friend videotaped the incident. ECO Johnson ticketed the subject for taking waterfowl out of season, hunting without a license, taking a migratory game bird without a federal duck stamp, taking waterfowl with an unplugged shotgun, and taking waterfowl with lead shot.

K9 Handler Locates Handgun - Sullivan County

On Feb. 28, ECO Wood responded to a crime scene in Kiamesha Lake to assist Sullivan County Sheriff's Office in finding a firearm tossed by a fleeing felon during a foot chase. Veteran K9 Officer Wood deployed K9 CJ to find the gun. Due to conditions at the location, K9 CJ could not find the weapon. Officer Wood decided to give it another try using his metal detector after determining the most likely location the felon would have discarded the weapon. The ECO zeroed in on a nearby ditch and his metal detector alerted him to an object under the snow. ECO Wood and a Deputy Sheriff carefully uncovered the loaded .45

caliber handgun. The subject is facing several charges in Sullivan County.

Keep Your Distance

ECOs in Suffolk County spent a few days providing security for seals. On March 1, Officers Dickson, Anderson, and Perkins responded to a call from Suffolk County Central Dispatch of a potentially injured seal on a boat ramp in Babylon Village. The ECOs arrived at the location and contacted the New York Marine Rescue Center to report the seal's condition and behavior. Experts at the rescue center, who determined it was likely a male harp seal visiting from arctic waters, advised that these types of seals stress easily. When stressed, the seals tend to consume sand and rocks that can damage their digestive systems. ECOs and Village of Babylon Code Enforcement set up a perimeter 150 feet around the boat launch to protect the seal from curious bystanders who had gathered to take pictures. On March 3, the arctic seal was transferred to the rescue facility and treated for dehydration.

Sunbathing Seal

On March 5, ECO Dickson received reports from the New York Marine Rescue Center of an incident involving a seal sunbathing at Gilgo Beach. According to the complaint, a bystander had attempted to put a dog collar on the seal and drag it back to the ocean. Officer Dickson arrived and canvassed the beach for the subject with the dog collar but could not find the offender. The

ECO established a security perimeter around the seal, allowing it to sunbathe in peace, without disturbance. The Officer also documented the condition of the seal and sent his findings back to the rescue center. To protect seals or other wildlife spotted on the beach, a minimum of 150-feet is the recommended distance for safe viewing. For more information on

ECO Safely Removes Elderly Couple from Car Fire

On March 7, while patrolling State Route 206 in the hamlet of Downsville, ECO Doig encountered a vehicle pulled over on the side of the road. As the Officer approached, he noticed flames shooting out near the exhaust and gas tank of the vehicle. ECO Doig quickly notified Delaware County 911 and immediately approached the vehicle to safely remove two elderly individuals from the car. Officer Doig then retreated to his patrol vehicle, grabbed his fire extinguisher, and put out the fire. The Downsville Fire Department arrived a short time later and determined the vehicle had a leaking gas tank and could have become engulfed in flames at any moment. The couple, unaware the car caught fire, were appreciative of ECO Doig's quick response.
